If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

Scope of Work (SoW) - MTS (General)

- Cleaning and housekeeping of office premises, common areas, corridors, staircases, washrooms and surrounding areas at SAI STC Imphal.
- Routine upkeep and general maintenance of office premises and campus facilities.
- Assisting in shifting of office furniture, equipment and materials within the campus.

- Support in minor repair and maintenance works as assigned.
- Assisting in office-related tasks including movement of files and documents.
- Assisting in loading/unloading of materials and stores.
- Collection and disposal of waste as per instructions.
- Any other general duties assigned by the competent authority from time to time.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Generic - Option Clause

The buyer may increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of contract, and once issued, the contract quantity or duration may be increased up to 25 percent, subject to GeM/GTC and budget availability. Bidders shall be bound to accept the revised quantity or duration.

2. Generic - Bidder Financial Standing

The bidder should not be under liquidation, court receivership or similar proceedings and should not be bankrupt. Bidder shall upload an undertaking to this effect with the bid.

3. Service & Support - Local Operational Presence in Manipur (Essential for Contract Performance)

The bidder shall have an existing functional office / branch office / operational office in the State of Manipur as on the bid opening date, for supervision of deployed manpower, grievance handling, wage coordination, emergency deployment and statutory compliance monitoring. The requirement is linked to the special logistical and operational conditions of the place of performance and shall apply uniformly to all bidders.

4. Documentary Proof for Local Office

The bidder shall upload documentary proof of the above office, such as any one or more of the following in the name of the bidder: GST registration showing additional place of business, trade licence, establishment certificate, rent / lease agreement, electricity bill, telephone / internet bill, or any other officially verifiable document evidencing an existing operational office in Manipur. Mere self-declaration or a proposal to open an office after award shall not be treated as sufficient compliance.

5. Experience Criteria

The bidder should have at least 3 years of experience, ending March prior to the bid opening, in providing similar manpower outsourcing services to any Central Government / State Government organization / PSU / Autonomous Body / Statutory Body. Copies of relevant work orders / contracts / completion or ongoing performance certificates shall be uploaded in support.

6. Turnover Criteria

The minimum average annual financial turnover of the bidder during the last 3 financial years, ending on 31 March of the previous financial year, shall be 30% of the bid value. Documentary evidence in the form of audited balance sheets or certificate from Chartered Accountant / Cost Accountant indicating turnover details shall be uploaded with the bid.

7. Startup Relaxation

DPIIT-recognized startups shall be eligible for relaxation in prior turnover and years of experience, subject to submission of valid recognition documents and subject to meeting the required quality, technical specifications, deployment capability, and all statutory compliance conditions of the bid.

8. Wage Disbursement and Bill-Stage Verification

The service provider shall disburse wages/remuneration to all deployed manpower through bank transfer within the time prescribed under contract and applicable law. Every monthly bill shall be accompanied by role-wise attendance, wage sheet, bank transfer proof, statutory deduction statement, PF / ESIC challans wherever applicable, and certification from the concerned Reporting Officer / In-charge. Buyer may withhold bill payment in case of discrepancy, short payment, ghost deployment, or non-submission of records.

9. Statutory Registrations and Labour Law Compliance

The successful bidder shall, before commencement of deployment and throughout the contract period, maintain all applicable registrations and compliances including PAN, GST, EPFO, ESIC, labour licence wherever applicable, professional tax and any other statutory requirement. Full compliance with all applicable labour laws, notified Labour Codes and corresponding operative pre-existing labour enactments shall be mandatory.

10. Onboarding of Existing Manpower - Continuity Condition

The successful bidder shall, as first priority, absorb / onboard the existing deployed manpower presently working at SAI NERC Imphal and its Units under the outgoing service provider, subject to their willingness.

s, continued requirement of the post, fulfillment of the minimum eligibility criteria prescribed in the bid, satisfactory performance report from the concerned Reporting Officer / In-charge / Coach, and completion of statutory or antecedent verification wherever applicable.

11. Replacement in Exceptional Cases

Where any existing deployed person is unwilling, ineligible, unsuitable, fails verification, or is not required against the approved deployment plan, the successful bidder shall provide a suitable replacement of equivalent qualification, suitability and deployment readiness without any operational disruption and without additional financial implication to the Buyer.

12. Continuity and Past Liability

The successful bidder shall ensure continuity of services from the date of commencement of the contract. The procuring entity shall not be liable for any past dues, claims, disputes or liabilities of the outgoing service provider or its deployed manpower. Such past liabilities, if any, shall remain the responsibility of the outgoing service provider as per law and contract.

13. Mandatory Bid Undertakings

The bidder shall upload the following signed and stamped undertakings along with bid: (a) undertaking regarding non-bankruptcy / non-liquidation; (b) undertaking regarding existing local operational office in Manipur; (c) undertaking regarding onboarding of existing eligible and willing manpower as per bid conditions; and (d) undertaking regarding compliance with wage, statutory and labour law obligations.

14. Fraud, False Documents, Ghost Deployment and Wage Short Payment

Submission of forged or false documents, non-existent office proof, ghost deployment, unauthorized deductions from wages, short payment to deployed manpower, or any material statutory non-compliance shall all constitute a material breach of contract and may lead to rejection of bid, withholding of payment, termination, forfeiture / invocation of performance security, and recommendation for debarment / legal action as per GeM, contract conditions and applicable law.

15. Scope of Work (SOW)

Buyer uploaded Scope of Work document shall form part of the bid. The SOW shall include role-wise qualification matrix, reporting structure, attendance and wage certification mechanism, replacement timelines, site distribution, and monthly compliance documents.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be

determined and redressed by the concerned Buyer Organisation only.

8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
