1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product

during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Buyer Added Bid Specific ATC**

**Bid for the Purchase of Mustard Oil**

**1. Validity of Bid** ● The approved rates will remain in force for one year from the date of the award of the contract, with a provision for extension for one year at the same rates with the approval of the competent authority.

● No request for a rate increase due to taxes, excise duty, natural calamity, strike, or any other reason will be entertained during the contract period. Any new tax imposed during the contract period will be considered.

## 2. Packaging and Delivery

● The packing of Mustard oil will be as per the requirement of the office i.e. Tins/Can/Plastic bottle or other wise.

● The bidder will supply the 100896 kg. Mustard oil to the office on designated place as desired by the department.

● In case of non-supply, short supply, or inferior quality supply, the department reserves the right to purchase the items from the open market at the bidder's risk and cost.

· The bidder must supply the required quantity of mustard oil whenever a demand is raised by the office, as per the delivery schedule provided at the time of each order.

## 3. Quality Standards ● The bidder will supply Markfed or Hafed branded Mustard Oil only.

● The department reserves the right to reject supplies not meeting prescribed standards.

● A certificate of genuineness from the manufacturer shall be submitted along with the supply for the acceptance of the material after award of the contract failing which the supply is liable for rejection.

Rate Quote :- The bidder shall Quote their rates @ per kilogram (not litter) for the supply of 100896 kg. Mustard oil.

**4. Option Clause** ● The purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

**5. Penalties** ● In case of non-supply, short supply, or inferior quality supply, the excess amount spent on procurement from the open market will be recovered from the bidder's pending bills and security deposit.

● If penalties are imposed more than five times, the contract is liable for cancellation, security forfeiture, and blacklisting for up to five years.

● In case the successful bidder is not supplying the material within the delivery period mentioned in the bid document then penalty @0.05% per day of the contract value shall be imposed. An undertaking shall be submitted in this regard.

**6. Payment Terms** ● Payments will be processed as per GeM norms and released within 30-45 days of the close of each supply.

● Payment will be made online, and bidders must provide bank details at the time of contract allotment.

**7. Local Office** ● The bidder's local office should be situated within the Tri-city area (Chandigarh, Mohali, Panchkula) and documentary proof must be submitted for the same with bid documents failing which, the firm shall be disqualified from the bid.

**7A :- Sample of Mustard Oil :-** The Seller must submit sample of the Mustard oil before end date/time of the bid, Failure to do so will result in the rejection of the bid. The sample of the item will be inspected by the Committee, and is liable to reject if not found upto the mark by the Committee

**8. Blacklisting and Legal Compliance** ● Bidder/ supplier/ Organization/Proprietor/ Any of the Director(s) should not be banned or suspended or blacklisted in the last five years by any Government/Public Sector Undertaking/Corporate Organization or convicted in any Court of law across India. An undertaking must be uploaded in the technical bid.

**9. Documentation** ● Documents once submitted by the bidder will be considered final. Any deficiency in the documents shall render the bidder liable for rejection without any reasons thereof.

● Each and every document required to be uploaded on the portal must be self attested by the bidder along with a seal.

· The bidder must possess a valid FASSAI (Food Safety and Standards Authority of India) Licence and must upload a copy of the same with the bid documents.

● Following Certificates to be uploaded with the bid document :-

a. I have carefully gone through the Terms & Conditions as mentioned in the above referred Tender document. I declare that all the provisions of this bid are acceptable to my Company / firm.

b. It has been certified that all information provided in bid is true and correct to the best of my knowledge and belief. No forged / tampered document(s) are produced with tender form for gaining unlawful advantage. We understand that Municipal Corporation, Chandigarh is authorized to make enquiry to establish the facts claimed and obtain confidential reports from clients.

c. In case it is established that any information provided by us is false / misleading or in the circumstances where it is found that we have made any wrong claims, we are liable for forfeiture of EMD/SD and or any penal action and other damages including withdrawal of all work / purchase orders being executed by us. Further Municipal Corporation, Chandigarh is also authorized to blacklist our firm/company/agency and debar us from participating in any tender/bid in future.

d. I / We assure the Municipal Corporation, Chandigarh that neither I / We nor any of my / your workers will do any act/s which are improper / illegal during the execution in case the bid is awarded to us.

e. Neither I / We nor anybody on my / our behalf will indulge in any corrupt activities / practices in my / our dealing with the department. ● Bidder is liable for rejection in case of any kind of deviation from terms and conditions/clauses stated in the bid document.

**10. Forms of EMD and PBG** ● EMD Submission: The Seller must physically submit a hard copy of the Earnest Money Deposit (EMD). Failure to do so will result in the rejection of the bid.

● Successful Bidder Shall submit the Electronic Performance Security (besides PBG which is allowed as per GeM GTC in the name of Commissioner M.C. CHD. A/C (Name of the Seller) for release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

**11. Dispute Resolution** ● Any dispute will be subject to the jurisdiction of Chandigarh only and referred to arbitration by the Commissioner of the Municipal Corporation Chandigarh or an appointed person. The Arbitrator's award will be final and binding on both parties.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
