This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. For MSME sellers, payments may be processed through a TReDS exchange in which the Buyer is registered, subject to applicable policy and regulatory guidelines. 1. 4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

2. Scope of Work: -

- a) To carry out Preventive Maintenance checks as per mentioned schedule of Air compressors and its Accessories as per approved Checklist and Maintenance Instructions provided by Compressor Manufacturer.
- b) For breakdown, service provider is to depute Service manpower and rectify the same with in strict time frame. Replacement of faulty parts like all air filters, Oil, Valves and other mechanical/ electrical/ instrumentation parts. (All spares and consumable will be provided by us on the written request basis.)
- c) The checklists are intended for general description of work to be carried out. They are not intended to cover all minute details. The work shall be executed in accordance with Manufacturer's O&M Manuals and modern techniques.
- d) Preventive Maintenance checks: -
 - Check overall cleanliness of equipments.
 - Cleaning of suction air filter. Replace with new one if it required.
 - Drain condensate from the oil collector.
 - Cleaning of filtering panel.
 - Cleaning the equipment and panel, if required.
 - Check the quality of oil and also oil level or top up the oil,
 - Replace the oil, if the oil quality is not good.
 - Check the condition of oil filter. Replace the oil filters with new, if required.
 - Check the condition of oil separator whether oil is coming along with air or not.
 - Tightening of all electrical power connections.
 - Check the condition of V belt. Replacing with new one, if required.
 - Check the condition of belt tension.
 - Check the functionality of electrical and instrument parts of components.
 - Replace desiccant if air quality is not found okay.
 - Replace moisture separator element, if required.
 - Observe the operational parameter of compressor.
 - Check the control panel parameters.
 - Check the condition of filters of compressor in running condition.
 - Check the oil and air leakage. Also arrest the leak, if found.
 - Check the abnormality sound and fault indications.
 - Record the various running parameters and vibration of compressors. And Note down the in service sheet and cross verify from In-charge supervisor. (i.e. Condition of components and replacement of component in consult from In-charge Engineer/ Supervisor)

3. Other Technical Requirements: -

- Preventive Maintenance (PM) is to be carried out as per maintenance schedule.
- The job should be carried only after receiving the work permit from SPM Narmadapuram.

- Filled checklist along with service sheet (vibration, running parameter of the compressor) is to be verified by In-charge Supervisor. After verification of Checklist along with job carried out then only, Preventive Maintenance be considered as completed.
- Spares and consumables are to be provided by SPM on written request from In-charge Engineer/ Supervisor
- All tools and tackles shall be carried by firm which is required for the maintenance. Service provider shall not claim any delay or compensation due to unavailability of tools and tackles.
- Removed/ worn out parts, cotton waste will be properly segregated and disposed as per EMS policy
- Firm has to carry all the safety equipment like helmets, air plugs, safety shoes etc which is required for maintenance.
- Firm has to depute service Engineer within 24 hrs in case of breakdown call.
- In Breakdown call, firm has to rectify the fault and operate the compressor within running parameters within a week.
- Service provider has to submit the Servicing Report (SR) of completed Breakdown Maintenance.

4. General Conditions: -

- Service provider has to arrange the proficient Manpower along with Maintenance Engineer to carry out the job. Details of manpower (Name, Age, I-card scan copy) are required to be provided to Concern Engineer for preparation of gate passes.
- Firm should strictly follow the security and safety norms of SPM inside the premises.
- Service provider should have insurance coverage of service Engineer.
- Accommodation and transportation facility up to SPM Narmadapuram will be arranged by the service provider at his own cost.

- Place of Work : Security Paper Mill Narmadapuram
- Period of Service : Two Years.
- Number of Visits : 04 Nos. for every unit in one year (Total 08 visit in Two Years)

2. **Destination:** Security Paper Mill, Narmadapuram (M.P.)-461005
3. Bidder Should Quote Prices Inclusive of GST And All Cost Components Such As Packing & Forwarding Details, Freight & Insurance Charges up to Destination etc. on FOR Security Paper Mill, Narmadapuram (Madhya Pradesh), India basis only.
4. **Liquidated Damages (LD) Clause:** If the contractor fails to deliver the goods and/or services or any instalment thereof within the Delivery Period, SPM Narmadapuram shall, without prejudice to other rights and remedies available to SPM, Narmadapuram under the contract, deduct from the contract price, as Liquidated damages, a sum equivalent to the rate of 0.5 per cent of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods or services.

7. **GST Return:** Supplier should file the GST returns for outward supplies in time. In case of any Input Credit Loss to SPM by way of their failure to file GST Returns in time, SPM reserves the right to withhold the payment of further supplies till production of evidence of filing of Returns.
8. **Service Period:** Two years SPM, Narmadapuram from the date of issue of GeM order.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
