1. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

- The Bidder shall abide by the provisions all relevant and applicable statutory labour and other laws, rules and regulations as applicable in the State of Uttar Pradesh.
- ESI Facility Clause: The service provider shall ensure compliance with the ESI Act 1948 and shall obtain ESI registration for all eligible employees under this contract. As there is no ESI dispensary/clinic presently available at Saifai, and the nearest ESI medical facility is located at Etawah. The service provider shall undertake alternate arrangements at its own cost for providing primary medical care, first aid, and emergency medical assistance to its deployed manpower at Saifai, till any such ESI medical facility/SRO becomes operational at Saifai. In case of referral to an ESI Hospital/dispensary at Etawah or any other notified ESI facility, the service provider shall ensure timely transportation and facilitation of the employee. The University shall not be responsible for non-availability of ESI medical facilities at Saifai. All obligations related to ESI benefits, medical care, compensation, and statutory compliance shall solely lie with the service provider.

The service provider shall coordinate with the ESIC authorities for availing ESI medical Services. Establishment of any ESI dispensary /SRO at Saifai shall be as per ESIC policy and shall not be considered as the responsibility of the university. If in exceptional circumstances, Medical prescription is provided to the service provider's personal at UPUMS Saifai, the entire cost of such Medical Advice (including investigation, medicine, procedures, and miscellaneous charges etc) shall be fully recoverable from the service provider.

 - Any strike, Work stoppage or obstruction of hospital services by the service provider in manpower shall be gross misconduct and material breach of contract.
 - The Competent Authority shall have the right to increase, decrease, or re-arrange the above-mentioned counters as per administrative exigencies. Further, during the expansion of the Hospital the required number of Manpower can be increased as per actual needs of uni

iversity. The above counters may be started in staggered/increased manner as per the need of University.

- The Service Provider is mandated to pay its staff by the **7th of each month**. Payment of wages must not be delayed due to any pending invoices or bill processing at the University.

- **OPTION CLAUSE:** The buyer can increase or decrease the contract quantity or contract duration up to as per scope of work at the time of issue of the contract. Bidders are bound to accept the revised quantity or duration

2. Performance Bank Guarantee (PBG)

3. Office Availability

The Service Provider must maintain a functional registered office within the **State of the Consignee (Uttar Pradesh)**. Valid documentary evidence (such as GST registration, Rent Agreement, or Utility Bill) must be submitted as proof of office location.

4. Contract Period

The proposed agreement shall be for a maximum duration of **three (03) years**. The contract will be awarded initially for **one (01) year** and may be renewed annually for up to **two (02) additional years**, subject to the s

atisfactory performance of the service provider and institutional requirements.

5. EMD Relaxation/Exemption

Relaxation or exemption from EMD submission shall be provided to eligible bidders (e.g., MSMEs/Startups registered in U.P.) strictly in accordance with **U.P. Government G.O. No. 23/2022/165/18-2-2022-97(L.U.)/2016 T.C. dated 29.06.2022**. Bidders seeking such relaxation must upload valid supporting documents.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
