Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Note: This tender is a single bid single tender for the nominated vendor for root glass window. All other bids, if any are received other than Single nominated bidder will be summarily/categorically rejected.

- a) Performance Security Bank Guarantee (PSBG) shall be in favor of MDL.
- b) Tender line items are inseparable and non-divisible in nature.

1. **DESCRIPTION & SCOPE OF WORK:** Supply of Root Glass Windows for Y-12654 of P17A
2. The bidder shall ensure following documents are essentially submitted along with bid:
 - (i) The bidder shall provide requisite documents as sought in Technical Specification along with the technical offer.
 - (ii) Bidders / Suppliers should enclose the additional documents as applicable to this tender.
 - (iii) Bidder's MSE status certificate.
 - (iv) GST % for all quoted line items.
 - (v) Prices for each of listed items has to be uploaded strictly in prescribed format provided on GeM portal. Bids received other than this given format will be rejected

Note: In any case, prices are not to be mentioned in Part-I bid.
3. Pricing: Prices shall be quoted for each line item on all-inclusive basis as per terms and conditions of this tender as applicable for door delivery to MDL Stores. Quoted prices shall remain firm & fixed during currency of contract.
4. Delivery schedule: PO+4 months. Part Supplies, Part Payment are acceptable
5. Consignee:
 - (a) Material scheduled for delivery are to be delivered at MDL Anik Store Chembur
Note:-In order to avoid inconvenience during the delivery of material, it is advisable for supplier to depute their representative in their own interest to coordinate the activities between the transporter, and MDL stores.
 - (b) Following document should be submitted along with material:
 - PO copy & subsequent amendments issued to it, if any.
 - Delivery Challans clearly indicating MDL Purchase Order No,
 - Packing List co-relating the items in the inspection report along with Inspection report.
 - Copy of Warranty Certificate, Preservation Certificate etc, if applicable.
 - E-Way bill details are to be submitted during the delivery of the items.
 - (c) Unloading of the equipment/ items will be arranged by MDL. In case of delivery of Large/ Bulk y/ Heavy consignments, supplier is required to give 2 to 4 day's advance intimation to MDL clearly indicating approx. dimensions and weight of consignments for arranging fork lift/crane for unloading.
6. PAYMENT MODE: All the payments to indigenous bidders due shall be made through Real Time Gross Settlement (RTGS) / National Electronic Fund Transfer (NEFT) by MDL.
7. LIQUIDATED DAMAGES (LD):
LD clause shall be applicable as per GEM condition @ 0.5% per week for delay in delivery of material.
Note: LD is applicable with maximum ceiling as per GeM terms and conditions.
8. Guarantee/warranty Requirement:12 months from date of receipt of material.

9. **INSPECTION:** Inspection agency: CQAE

- (a) Receipt Inspection: MDL with Warship Overseeing Team (WOT) & ship staff shall carry out necessary inspection of the items on receipt in the MDL on the basis of appropriate MDL Inspection system requirements & the Inspection documents submitted by suppliers. Any objection raised by MDL inspection team against quality of material or workmanship shall be satisfactorily corrected by the supplier at his expenses including replacement as may be required within shortest possible time within 30 days. Items damaged during transit shall also be rectified or replaced by the supplier within shortest possible time.
- (b) Rejection of the material: Any portion of the equipment found defective/rejected, the supplier shall collect the same at his cost from the MDL Yard, all incidental charges being born by supplier, (inclusive of custom duty, if payable), within 30 days from the date of intimation to the supplier of such rejection. The MDL reserves the rights to dispose-off the rejected item at the end of a total period of 90 days in any manner, to the best advantage to the MDL & recover storage charges & any consequential damages, from sale proceeds of such disposal.

10. Indemnification: The Bidder / Supplier / Contractor, his employees, licensees, agents or Sub-Supplier / Subcontractor, while on site of the Purchaser for the purpose of this contract, indemnifies the Purchaser against direct damage and/or injury to the property and/or the person of the Purchaser or that of Purchaser's employees, agents, Sub-Contractors / Suppliers occurring and to the extent caused by the negligence of the Bidder / Supplier / Contractor, his employees, licensees, agents or Subcontractor by making good such damages to the property, or compensating personal injury and the total liability for such damages or injury shall be as mutually discussed and agreed to.

11. Purchaser's Property: All property (such as materials, drawings, documents etc) issued by the Purchaser or any other individual or firm on behalf of the Purchaser in connection with the contract shall remain confidential, being the property of the Purchaser and the Bidder/Supplier/Contractor shall undertake to return all such property so issued and will be responsible for any or all loss thereof and damage thereto resulting from whatever causes and shall reimburse the Purchaser the full amount of loss and damage.
