3. The Make / Brand of all the Items / Materials to be supplied shall be from the approved list. The items not covered in the approved list shall be of ISI mark and should be got approved by the competent authority before execution of the work. Competent authority is Sr. DCM/NED.
4. As the tender is on outcome activity basis, the scoring for "size of work force" component of technical marking will not be applicable. The scoring marks will thus become 45 out of 75 as the weightage factor (25 %) of size of workforce is not applicable.
