1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Certificates

Payment: The Driver of the Vehicle shall maintain standard Log Book Indicating details of daily running of vehicles and must get It signed, on a day to day basis, by the user of the Vehicle or by the authorized representative. The endorsement in the Log book will be the basis of payment of bills. The contractor will have to submit his monthly bill to DEN/III/SDAH with requisite certification for each trip duly signed by consigner. After scrutiny the bill at the office of DEN/III/SDAH it will be accepted and forwarded to associated finance f or payment.

13. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

SCOPE OF WORK (SPECIAL CONDITION OF CONTRACT)

(1) The contractor(s) is expected to provide best quality of vehicles (Bharat Stage VI Certified) and efficient Drivers for best quality of service. The Vehicles offered shall not be more than one year old.

(2) The scope includes payment of all statutory liabilities for the vehicles and the driver(s) by the contractor, for which the Railways will make no extra payment.

(3) The offered Vehicles shall be SUV or equivalent as specified, with proper documents on hire for Hiring of one non AC vehicle for official use of **AEN/BR/HQ** and **AEN/BR/II/HQ** for day to day in all respect for **24 months**.

(4) The quoted rates includes all the cost to be incurred by the Agency for supply of Vehicles, Including Driver, maintenance, fuel, registration, repair, driver's salary etc and any other incidental expenses, if any. No other payments on any account will be admissible to the Agency.

(5) **PENALTY:** The Railway Administration will have the right to impose penalty of Rs.2000.00 (Rupees one thousand only) for every breach of contract or failure in supply of the vehicle.

Such penalty will be at the discretion of Railway Administration. In case of failure to follow any of the conditions mentioned herein liquidated damage will be charged by Railway Administration which is considered reasonable by the Railway Administration in relation to the rates quoted by the firms. If the contract is rescinded, the performance guarantee shall be en-cashed and the balance work will be got done independently without risk and cost of the original contractor.

(6) The vehicle shall be available to the Railway with fuel, engine oil etc. normally on all days of week irrespective of holidays with 12 hrs availability. However, occasionally the duty hrs and timings may vary as per requirement of Railway and Contractor shall not have any claim over that. Duty hrs shall start from the time driver with vehicle reported to Officer in charge and will end at the time when the driver of vehicle is discharged off by the Officer in charge and travelled from start of duty to end of duty will only be paid as per logbook. The vehicle will be stationed at any station/place as per directions of Railway authority.

(7) No accommodation & Garage facilities will be provided by the Railway to the driver & for the vehicle. Contractor has to make his own arrangements for these facilities.

(8) The contractor shall be completely responsible for safe running of vehicle. The Railway will not be responsible for any loss, damage, repairs, maintenance or accident to the vehicle or driver.

(9) Description of the vehicle i.e. (a) Make, (b) Registration Numbers, (c) License Number, (d) Copy of Road Tax Clearance token, (e) Fitness certificate, (f) Reference of Blue book should be submitted by the Tenderer before making of Agreement.

(10) The driver should have a valid driving license and the vehicle should be insured against accident etc as per rules and statutory obligations. In case of any accident or mishap resulting in loss of damage to property or life, the sole responsibility for any legal or financial implication shall rest with the contractor.

(11) The vehicles will be hired for a period of two years from the date issue of a acceptance letter.

(12) The contractor shall not act as a Broker for hiring vehicles from other firm/ agency.

(13) The seats of the vehicle should have good and clean cloth covers, which must be changed regularly.

(14) The driver should always carry his identity card, driving license etc., contractor will keep one set of driver for entire period of contract with approval of officer concern. If at all it becomes necessary to change the driver of vehicle, prior approval of officer will be taken. Otherwise a token penalty of Rs 5000.00 may be imposed on if deemed necessary by the Railway Authority.

(15) The driver should always wear proper white Uniform (Full Trouser & Shirts).

(16) The vehicle shall move as per the direction of Controlling Officer or other Railway Official as per requirement.

(17) In case un-authorized/illegal materials are found in the vehicle, the responsibility shall solely rest with the contractor for the same.

(18) The rate of hire are also inclusive of cleaning and changing of sheets curtains of vehicle at least fortnightly including extra clean cover should be available to provide during cleaning period of existing covers.

14. **Buyer Added Bid Specific SLA**

Text Clause:

1. The agency must be registered with EPFO/ESIC.
2. The driver should possess experience of 5 years in driving passenger vehicle (Commercial Driving Licence).
3. The driver must possess EPF and ESI challan of atleast 03 months prior to joining the duty for first time.
4. Vehicle must be provided by the owner only. Any form of subletting or loaning or delegation of vehicle from any other owner is not allowed.
5. Any vehicle which is rented or being provided by third party is not allowed.
6. The agency must provide relevant non bankruptcy declaration.
7. The agency must provide relevant non blacklisted declaration.
8. Drivers should be mandatorily paid in their bank accounts as per The Contract Labour (Regulation and Abolition) Central Rules, 1971. Please Submit Driver salary statement.
9. Tenderer must submit T2: Bank Liquidity:- The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5% of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with her stamp, signature and membership number shall be submitted by the bidder along with bid. Banking reference should contain in clear terms the amount that bank will be in a position to lend for

this work to the applicant/member of the Joint Venture/Consortium. In case the Net Current Assets (as seen from the Balance Sheets) are negative , only the Banking references will be considered. Otherwise the aggregate of the Net Current Assets and submitted Banking references will be considered for working out the Liquidity.

The banking reference should be from a Scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
