1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

## 8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

### (1) Eligibility Criteria -

(A) Past Performance - The bidder should have satisfactorily completed in the last three previous financial years and the current financial year up to the date of opening of the tender, one similar single contract for a minimum of 35% of estimated bid value to any Central / State Govt. Organization / PSUs. Completed contract includes on-going contract subject to payments of bills amounting to at least 35% of estimated bid value. The bidder shall submit details of work executed by them and completion certificate from competent authority along with bid for the service contracts to be considered for qualification of work experience criteria clearly indicating the nature/scope of contract, actual completion cost and actual date of completion for such contract. Non fulfilment of eligibility criteria by the bidder shall result in summarily rejection of his/their bid. Similar Service means all type SUV/MUV/Sedan Vehicle Service.

(B) Financial Eligibility (Financial Standing)- The Bidder should have an aggregate financial turnover not less than 1.5 times the estimated bid value during the last three previous financial years and in the current financial year up to the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with her stamp, signature and membership number shall be considered.

(2) The contractor shall supply only valid vehicles with necessary papers and documents. The vehicle details, i.e. make, registration number, year of registration, insurance certificate, non-polluting vehicle certificates, driver name and license number etc. should be submitted before deployment of the vehicle.

(3) If the vehicle is out of order, an alternative equivalent vehicle in good condition will have to be temporarily made available to the user immediately, failing which vehicle will be hired from open market and actual payment made for it along with a penalty of Rs. 2,000/- (Rupees Two Thousand Only) per day will be recovered from the dues payable to the contractor in addition to non-payment of hiring charges for the period of break down. In this regard, the decision of the user shall be final and binding on the contractor. It shall be the responsibility of the contractor to inform the vehicle user and railway administration regarding any change of vehicle/driver well in advance.

(4) The drivers of the vehicle should be courteous, polite and possess the valid driving license, identity card and they should be provided with white uniform/dress. The drivers engaged by the contractor shall have clean background and clean police record. A self-declaration regarding this shall be submitted by the contractor.

(5) As far as possible the contractor should provide a fixed vehicle and fixed driver to the user. The performance of the driver and the vehicle should be up to the satisfaction of the user. The driver of the vehicle should be provided with a cell phone (having incoming and outgoing facility). The details of the driver cell phone number must be provided by the contractor.

(6) Additional Condition - The contractor must also ensure the following terms :-

(a) Provision of vehicle availability on a 24x7 basis.

(b) Deployment of drivers in shifts (day and night) to ensure uninterrupted service.

(c) Grant of weekly rest to drivers, with arrangement of substitute/reliever drivers on rest days.

(d) Frequent change of drivers to be avoided to ensure continuity and familiarity with duties.

(e) Provision of drinking water in the vehicle (1 litre per day, i.e., two 500 ml bottles).

(f) Drivers should be well-versed with local routes and capable of handling protocol assignments efficiently

Note - Bidder may please note that no post-bid correspondence for submission of additional documents shall be entered into/entertained after opening of bid.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. 12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
