1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

Right of acceptance and Rejection of Bidding/Tenders:

1. Buyer reserves the right to accept at their sole and unfettered discretion any tender/bid for whole or part quantities or reject any or all tenders/bidders without assigning any reason thereof. No claims for compensation or otherwise whatsoever will be considered by buyer from the Bidder/tenderers.

2. If a Bidder/tenderer resorts to any frivolous, malicious or baseless complaints/ allegations with an intent to hamper or delay the tendering/bidding process or resorts to canvassing / rigging/ influencing the tendering process, buyer reserves the right to debar such tenderer/bidder from participation in the present/ future tenders/bidding up to a period of 2 years.

3. Compensation for submission of Tenders: The Bidder/tenderers shall not be entitled to claim any cost, charges or incident

entals for or in connection with the preparation and submission of the tender/bidding.

4.Past Performance of the Bidder/Tenderer: buyer reserves the right to reject the tender on receipt and/or on evaluation, if the past performance of the Bidder/tenderer has not been found satisfactory.

5.Discount: If any, to be indicated in the price format only

6.Certificate from the supplier that the material supplied under the contract should be provided then payment is due in accordance with the terms of contract at the time of presentation.

7.Buyer shall not be bound to accept the lowest bid/tender and reserves right to accept any or more bid/tenders in part. Decision of buyer in this connection shall be final.

8.THE BIDDER/TENDERER IS EXPECTED TO EXAMINE ALL INSTRUCTIONS, forms, terms, and specifications in the bidding documents. Failure to furnish all information required in the bidding documents or submitting a Bid not substantially responsive to the bidding documents in any respect may result in the rejection of the Bid.

9.PROFESSIONAL EXCELLENCE AND ETHICS. Bidding/Tendering Authority requires that all bidder/Tenderers participating in this Bid adhere to the highest ethical standards, both during the selection process and throughout the execution of the contract.

10.If the quality of the supplied material is found to be unsatisfactory fully or in part, the material will be rejected and the successful Bidder/tenderer will be held responsible to replace the material in full and without final replacement no payment shall be made.

11.Need to Provide PRI Experience Certificate.

12. All rights about cancellation of bid in any circumstance with or without any intimation reserves to buyer.

13.As per Requirement Seller should be ready to provide required product to install at required location.

14 .If Seller Fails to Provide required documents seller will be rejected from Bid and there should be no objection from seller in those regards ,such seller need to participate in this Bid .

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
