If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. II. IN ORDER TO AVOID THE REJECTION OF BID/QUOTATION, BIDDERS ARE ADVISED TO SUBMIT THE BID WITHOUT MENTIONING ANY PRICE OR ANY TAXES, LEVIES, DUTIES IN TECHNICAL BID. AS PER GEM, ALL QUOTES SHALL BE INCLUSIVE OF THESE ELEMENTS AND BIDDERS SHALL SUBMIT PRICE ELEMENT(S) IN FINANCIAL BID ONLY.

III. Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
