### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

#### Buyer Added text based ATC clauses

- a. Annual turnover required by buyer in crores : 0.05 Crores.
- b. Agency will have to submit Performance Security Deposit (PSD) @ 5% of the total contract/order value in the form of bank guarantee, the same will be returned within 3 months of the successful completion of the contract.
- c. Undertaking to the effect that firm has not been blacklisted by any Central/State Govt. organisation / PSU / Public listed Companies.
- d. Undertaking to the effect that no statutory payment like EPF & ESI challan is outstanding/due for payment since last 2 years with EPFO & ESIC.

Acceptable documents as proof of address are (i) Trade licence of Kolkata Municipal Corporation, (ii) Certificate of enlistment of KMC, (iii) ITR of last 3 years with registered address (iv) GSTIN registration certificate not more than 3 years old with registered office at Kolkata.
- h. Agency will provide the name and contact details of the nodal person to whom may be contacted.
- i. Wages must be enhanced from time to time as per orders issued by Government of West Bengal, Labour Commissionerate, Kolkata from time to time.
- j. Buyer reserves right to operate 100% option clause to extend the contract after satisfactory completion of 80% of the contract prior to expiry of the original contract.
- k. Buyer reserves right to cancel the contract at any time without showing any reason.

#### अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
