2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.

6. The certification body (Bidder) must have accreditation from an Indian accreditation board NABCB (National Accreditation Board for Certification Bodies), which is a member of the International Accreditation Forum (IAF), covering ISO 9001:2018. Additionally, the participating certification bodies must have valid accreditation for ISO 50001:2018, with the accreditation clearly indicating the certification body's name, accreditation number, issue date, and expiry date. Issuing certificates through channel partners or sister companies shall not be allowed.

7. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / item is bunched with the major regular product Category Item).
