2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

SCOPE OF WORK

The scope of work includes the following.

1. Service engineer shall provide supervisory assistance or technical assistance to the RCF site engineer in troubleshooting of problem, preventive and breakdown maintenance.
2. M/s Hitachi shall depute service engineer who is conversant with operation, maintenance and troubleshooting of 3.3kv, 820kva Hitachi make VFD as and when requisitioned by M/s RCF during any breakdown or emergency.
3. M/s RCF shall arrange shutdown of VFDs (if required) for carrying out maintenance job safely.
4. M/s Hitachi shall arrange special instruments (storage Oscilloscope-CRO)/ tools including laptop and compatible software etc. M/s RCF shall inform the requirement before deputation of the service engineer.
5. When called the service engineer shall carry out complete check of the entire system to the satisfaction of M/s RCF so that machine can be started safely.
6. The service engineer shall be able to guide/provide the solution in least possible time.
7. M/s Hitachi shall be revert back with root cause of the problem and also suggest the solution so that problem of similar kind should not come up in the future.
8. General purpose tools and tackles required for carrying out the work will be provided by RCF free of charge. Also supporting manpower will be provided by RCF free of charge.
9. Party shall arrange for spares required for successful completion the job free of cost as the contract is comprehensive. The scope included replacement of defective parts, PCBs, switches, fuses and all other components required for satisfactory performance of the VFD. The MVD input transformer is excluded from this scope. However vendor shall provide repairs services as and when required.
10. All the work shall be carried out as per "preventive maintenance manual" of the OEM.
11. Vendor shall carry three visit per year (once in a four month).The vendor shall submit detailed visit reports along with the invoice. Even if shutdown is not possible RCF will provide VFDs for online inspection as per CAMC schedule.
12. Service engineer from M/S Hitachi shall visit site within 24-48 hrs from intimation in case of emergency.
13. During the contract period, if any material to be sent for repairing then one way (RCF to HHPE) cost & transportation to be arranged by RCF and one way (HHPE to RCF) to be arranged by HHPE with necessary documents and proper packing.
14. Necessary gate entry for manpower as well as material to be arranged by RCF.

Tenure of contract: Tenure of contract shall be **Five Years** starting from 02.02.2026 to 01.02.2031.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code

on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
