ट्रेड्स भुगतान संबंधी विवरण/TReDS Payment Details

This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. For MSME sellers, payments may be processed through a TReDS exchange in which the Buyer is registered, subject to applicable policy and regulatory guidelines. Accordingly, sellers intending to avail payment through TReDS are required to be registered with at least one TReDS exchange in which the buyer is registered.

1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
6. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Buyer Added Bid Specific ATC**

SCOPE OF WORK AND PAYMENT TERMS OF CUSTOM BID FOR SUPPLY OF NEW COMPATIBLE CARTRIDGE/REFILLING/SERVICING OF 150 PCS OF PRINTER TONER/CARTRIDGE.

Refilling and repair services of cartridge of various companies/model laser printers/copiers at below mentioned offices/depot of Food Corporation of India, under FCI Divisional Office Nadia, FSD Kalyani Campus, Kalyani, W.B.

Offices-- DO Nadia, FSD Bhatjangla, FSD Kalyani

Number of printer (appx.)-- 60 pcs.

Brand-- HP, Canon, Brother, Epson, Any Other.

Service specific STC:

1. The service provider shall arrange to supply new compatible cartridge of specific model/make and made as and when required. As such priority should be given for supply of new compatible cartridge however in case of unavailability of specific make and made of cartridge, the toner refilling/service may be done on spot within 24 hours of lodging call/request.
2. During refilling/service (if done), the toner dust and required hardware like (drum, magnet, roller and blade or any other) has to be supplied by the service provider at his own cost. No extra cost will be borne by FCI.
3. The service provider shall provide service in such a manner so as to ensure print quality of all the cartridge remains clear and crisp without any lines and smudges. In case of un-satisfactory performance, deduction will be made from the bill on pro-rata basis. Repeated instance of un-satisfactory performance may invite termination of contract.
4. The service provider may visit all the above offices to access the existing printer/cartridge (models) before quoting the rate. The service provider shall quote a single consolidated rate for supply of 150 pcs of new compatible cartridge/refilling/setvicing calculated taking into account average cost of all types of cartridge of specific make and made.
5. The service provider shall allot at least two phone no. which must be available to lodge service calls.
6. The service provider has to provide new compatible cartridge of specific model/make or arrange refilling for additional printers also apart from those mentioned above, if such printers are purchased by this office or supplied by FCI higher office in between the tenure of contract.
7. The service provider shall quote price for supply of new compatible cartridge/refilling/servicing of 150 pcs of toner/cartridge including GST and or any other applicable taxes failing which FCI reserves all the rights to deduct the same from their bill.
8. This contract does not guarantee work for 150 pcs, the payment will be made strictly based on actual utilization.
9. Payment for new compatible cartridge/refilling/servicing cost will be processed/quarterly only upon successful completion of work and submission of GST bill with all supporting call reports duly signed by concerned section/office.
10. Service provider will have to provide service/replace cartridge free of cost if problem arises within 15 days of supply/refilling/servicing of cartridge.
11. The contract will be valid either upto 1 year or up to supply of 150 pcs of new compatible cartridge/refilling/servicing of specific model/make whichever is reached earlier.

12. The GEM contract of service provider will be liable for termination if the firm fails to report on the joining date.

13. Divisional Manager, FCI DO Nadia reserves all right to terminate the said contract without mentioning any reason whatsoever. And for any dispute, decision of Divisional Manager, FCI DO Nadia shall be final.

14. The bidder shall submit an undertaking agreeing to all terms and condition mentioned here.

Additional terms & conditions/formula to compute new supply, refilling/servicing cost of toner per unit basis from total financial quote.

Illustration & [Terms:-](#)

1. The cost of new compatible cartridge of specific model/or refilling will be calculated by dividing the total price quoted with 150 pcs. For example, let say if the bidder quotes Rs 45000/- & selected L1 for the contract, then per toner charge (New or refill+parts) will be derived as $45000/150 = \text{Rs } 300/\text{pc}$ including GST.

2. However, payment will be strictly made based on actual work done on per toner basis during the contract period, there is no guarantee or rights exists with the service provider to claim full payment of 150 toner by supplying compatible cartridge or refilling less no. of cartridge. But the maximum cost will be paid upto 150 pcs only. The contract shall be valid either upto 1 year or upto 150 pcs whichever is reached earlier.

List of documents to be submitted/mandatory for Technical qualification:

1. Certificate of compliance committing to obey all above terms.
2. GST and Trade License.
3. Registered office in the state of West Bengal.
4. Experience certificate of similar work done (1 year).
5. MSME & MII certificate (for claiming preference/relaxation).

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
