1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 1. This category is BIS Scheme - 1 compliant. Catalogs must have valid and active CM/L license number owned by the applicant themselves. In case of non-compliance, appropriate action may be taken against OEM / Brand / Seller as per the GeM IM Policy.

The gas shall be supplied compressed in Cylinder. The design of the Cylinder, pressure of gas in Cylinder, packing, marking, painting, labelling, storage and transport of Cylinder shall be in accordance with the Gas Cylinder Rules , with such modifications as may be ordered from time to time by the CIE, PESO, DPIIT, MoC&I, Gol.
