3. 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. **Forms of EMD and PBG**

6. **Payment**

8. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

1. Contract Extension: Duration of the service contract may be extended up to one year beyond the initial contract duration (subject to satisfactory performance and mutual consent). Bidders are bound to accept the revised duration.

2. Contracted quantity revision: The buyer can increase or decrease the contract quantity at the time of issue of the contract or during the contract period. Bidders are bound to accept the revised quantity.

3. Geographic Presence: Office registration certificate: An office of the service provider must be located in the Gujarat State. Documentary evidence to be submitted as mentioned in Technical Evaluation.

4. Price Break Up for Financial Evaluation: Bidder MUST submit Price Break Up for Financial Evaluation in the prescribed format (Annexure-3) as mentioned in ATC with bid. Bid without Price Break Up for Financial Evaluation will not be considered and will be liable to be rejected.

The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs

and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
