1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

3. Forms of EMD and PBG

SCOPE OF WORK

- The scope of work under this contract comprises outsourcing of housekeeping service (unskilled) at 400 K V Sub Station Complex under Operation & Maintenance Division, BBMB, Bhiwani and 220kV Substation Complex Charkhi Dadri is as detailed under: -

- a). Sweeper shall perform the duties of 8 Hours duration from 08:00 AM to 05:00 PM with having 01:00 Hour break from 12:00 Noon to 01:00 PM on all working days or as directed by the office-in-charge.
- b). The manpower provided by the contractor will be entitled to one weekly off, National Holidays etc. as per Labour Laws.

3. Including of manpower/personnel: - Manpower/Personnel provided by the contractor should know that politeness is expected from them in their relations with the office and if any case of incivility be proved against them, contractor have to replace the Sweeper on priority base.

4. Qualification: -

- a). Safai Sewak: - Should be literate, physically sound and mentally sound.

5. Responsibility of duties: -

Safai Sewak (Full time) against office contingency: - The personnel will work of sweeping, cleaning of offices, rest houses, control room, roads, berms, parks, sewerage etc. and dispose of garbage etc. in the premises of 400 KV Sub Station, BBMB, Bhiwani and 220kV Substation BBMB Charkhi Dadri.

6. Mode of payment: -

- a). Salaries and allied charges shall be paid to personnel deployed by contractor at BBMB, Bhiwani as per Haryana Kaushal Rozgar Nigam Rates. Wages will commence from the date of reporting at BBMB office Bhiwani and BBMB office Ch. Dadri.
- b). Rates as quoted by the contractor will not change under any circumstances during the contract period.
- c). Contractor shall send the authenticated signed Duty Certificate in respect of each worker by the 1st of each month.
- d). Contractor will prepare the salary bill/invoice and submit to the officer-in-charge of BBMB on or before 5th of each month.
- e). The contractor shall disburse the wages to the workers through bank account on or before 7th of each month.
- f). BBMB shall make reimbursements of the wages based on the invoice raised by contractor within 10 working days of receipt of invoice and make the payment to contractor through D/RTGS/NEFT etc. on monthly basis.
- g). The payment of EPF/ESI & others legal liabilities shall depend on the contractor. BBMB shall not be responsible for these liabilities.

7. Wages: -

- i). The provision of wages has been made as per Haryana Kaushal Rozgar Nigam Ltd. Letter No. HKRNL/Finance/1683 dt. 12.09.2025 (Monthly wages) (copy attached).

- ii. Analysis of rates regarding wage & other charges to be paid to contractor is attached. In addition to the rates mentioned in above letters, the labour cess @ 1%, contractor profit @ 10% + GST @ 18% shall be paid extra.

8. Character verification: -

It is duty of contractor to certify that personnel/manpower provided by the contractor are of good moral character and have no criminal record and no departmental as well as judicial proceedings are pending/initiated against them earlier.

9. An agreement on non-judicial stamp papers for total value of Allotment order shall be executed between the Contractor and the Department within 15 days from the issue of Contract order or from the date commencement of work. On acceptance of the tender, the contractor shall either himself remain available at site of work or arrange the availability of an accredited representative, fully authorized in writing, at the site of work to receive instructions of the Engineer-in-Charge or his representative and to ensure prompt compliance thereof.

10. CONTRACTOR LIABLE FOR PAYMENT OR COMPENSATION TO INJURED WORKMAN OR IN CASE OF DEATH: -

In every case in which by virtue of the provision of the section 12, Sub section (1) of the workman's compensation Act 1922, the BBMB is obliged to pay compensation to a workman employed by the contractor in execution of work, the BBMB will recover from the contractor the amount of compensation so paid and without prejudice to the rights of BBMB under section 12, sub section (ii) of the said Act. BBMB shall be at liberty to recover such amount or any part thereof by deducting it from the security deposit or from any sums due by the BBMB to the contractor whether under this contract or otherwise BBMB shall not be bound to contest any claim made against it under section 12, sub- section (1) of the said Act except on the written request of the contractor and upon his giving to BBMB full security for all costs for which BBMB might become liable in consequence of contesting such claim.

11. Arbitrations: -

In case of any dispute or difference arising out of the implementation or interpretation of any of the clauses of the contract, the same shall be settled as per the provisions of the Arbitration & Conciliation Act - 1996 and the matter will be referred to Sole Arbitrator appointed by mutual consent of both parties and in case of any party not agreeing for appointment of Sole Arbitrator, each party will nominate their own Arbitrators and these two arbitrators will further nominate on person to act as umpire of Arbitral Tribunal whose decision shall be final and binding on both parties.

12. Period of contract: -

The contract will be commenced from 1st March, 2026 to 28nd Feb, 2027.

13. The entire risk and responsibility regarding any type of accident/damage, death of workman etc. during performing of duties by manpower will lie with the contractor.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The

Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
