1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product

offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

**Eligibility Criteria**

1. The bidder must have their own shop in South Andaman region (any relevant documentary evidence must be submitted).
2. The bidder must possess a valid FSSAI licence/ registration certificate
3. Bidding firms fulfilling the above criteria must mandatorily upload the following documents/certificates. Failure to do so will result in the rejection of the bid.
  - a. Shop registration certificate/ document.
  - b. Self-attested copy of PAN card of the firm or proprietor/ partner.
  - c. Self-attested copy of GST registration, if applicable.
  - d. FSSAI (Form-C) A&N Administration Food Safety Standard Authority of India license/ registration certificate under FSSAI Act, 2006.

- e. Experience certificate for supply of provisional items to Govt. departments/ organizations/ public undertaking/ Autonomous bodies/ Company etc. for minimum period of one year.
- f. Other documents, if any.

**Terms & Conditions**

1. The quality of items should be good/ fresh.
2. The items should be supplied on the strength of the inmates lodged in the jail as per the requisition given by the storekeeper at main gate of District Jail, Prothrapur, Sri Vijaya Puram .
3. The bidder should carefully go through all the clauses and details indicated in the bid document before quoting the rates. No excuse that the conditions have not been read or understood will be entertained later. However, if the bidders have any doubt about any portion of the bid or require clarification on any of the aspect, they may contact the store section of the District Jail, Prothrapur, Sri Vijaya Puram for clarification before submission of the bid.
4. The rate quoted by the firms for the items should be final inclusive of all taxes/ charges as applicable.
5. Revision of rates will not be allowed after opening of the bid.
6. The bidders should submit an EMD of 2% of the estimated cost. The EMD must be submitted in an acceptable form, drawn in favour of the Drawing and Disbursing Officer, District Jail , Prothrapur, Sri Vijaya Puram, from a commercial bank.
7. The successful bidder shall submit a Performance Guarantee @ 5% of the total contract value within two weeks (14 days) from the date of award of the contract. The Performance Guarantee must be submitted in an acceptable form, drawn in favour of the Drawing and Disbursing Officer, District Jail, Prothrapur, Sri Vijaya Puram, from a commercial bank.
8. The validity period of the contract shall be 01 year. However, it may be extended for a further period of up to 03 months or till finalization of the new bid, whichever is earliest.
9. No relaxation shall be allowed for delayed supply under any circumstances, except under force majeure conditions such as natural calamities, strikes, or other unforeseen events beyond the control of the supplier.
10. It is the sole responsibility of the seller to deliver the items in good condition. If the items are found spoiled the same should be replaced immediately with fresh items by the supplier without any additional cost.
11. In case the suppliers fail to honour the commitment after acceptance of the contract this department will be liable to forfeited the performance s

security lying with us. More than one such default would also cause debarment & exclusion of such bidders and cease all transactions with the firm.

12. The bid inviting authority at its discretion depending on the actual need of the department reserves the right to increase or decrease the quantity of the required items up to 25% without any change in the terms and conditions and prices quoted by the bidder. In full or in part from L1 bidder by stating reason do so.
13. If the seller fails to deliver any or all of the items within the original/ re-fixed delivery period(s) specified in the contract, the buyer will be entitled to deduct/ recover the Liquidated Damages for the delay, unless covered under force majeure conditions, @0.5% of the contract value of delayed quantity per week or part of the week of delayed period as per-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/ dispute of any sort whatsoever.
14. The acceptance of bid will rest with Superintendent, District Jail, Prothrapur, Sri Vijaya Puram, which does not bind itself to accept the lowest rate or any bid, and reserve to itself full rights to reject any or all bids without assigning any reason thereof.
15. The bidder shall not sub-let or entrust the work to any other agency.
16. Advance payment will not be made under any circumstances.
17. The supplier shall submit the bills on the GeM portal in parts or in total.
18. The supplier shall comply with all state, local & central laws, statutory rules, regulations etc. as applicable
19. Arbitration and Jurisdiction: Both the parties of the Agreement shall make every effort to resolve any disagreement or dispute arising between the parties or in connection with the Agreement amicably at the first instant. In case of failure, all disputes, controversies or claim between parties shall be referred for arbitration to the sole arbitrator to be appointed by Hon'ble Lt. Governor, A&N Islands for the purpose. ## 2. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).

If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
