1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Consortium: In case of Contracts, wherein the seller alone does not have necessary expertise, the seller can form consortium with other sellers for submission of the bid, with one of the consortium company as leader. However, each and every member of the consortium shall be equally responsible for the complete execution of the project contract. An undertaking to this effect is to be uploaded with bid.

4. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

5. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally

liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

6. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

8. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

9. **Service & Support**

10. **Past Project Experience**

SCOPE OF WORK, SPECIAL TERMS & CONDITIONS OF CONTRACT

1. "Month" means any Calendar month.
2. "Day" means a day starting from 00.00 hrs. to 24.00 hrs.
3. "Reporting Place" Seamen's Employment Office, Mumbai where the vehicles shall generally report for duty or shall be released after completion of duty unless specified otherwise. Reporting place may be changed at any time during the currency of the contract.
4. "Work Site" means the location of operations of Seamen's Employment Office, Mumbai or any other work center / station of Seamen's Employment Office, Mumbai Shipping Office Mumbai.
5. "Duty Hours" means the duty hours of vehicle specified by Seamen's Employment Office, Mumbai Shipping Office Mumbai.
6. "Route" means the shortest possible approachable road between the two points or otherwise as prescribed by Seamen's Employment Office, Mumbai.
7. "Driver" means the paid employee(s) of the contractor engaged by him for driving the Light vehicle and in possession of valid professional driving license of 3 years or more as per the statutory requirements of Motor Cab Rules and Laws applicable from time to time.
8. The vehicles offered for duties should have properly cleaned & odorless interiors and should be have neat seat covers. They should also be fitted with reverse horn. The Bidder should depute one contact person

for Seamen's Employment Office, Mumbai Shipping Office Mumbai cab requirements and overall activity.

9. The vehicle hired under the contract should be manned by an experienced and competent driver(s), as per prevailing RTO requirements.

10. The driver must have a mobile phone available with him for smooth co-ordination and service-execution and the same should always be in working condition. In case, the driver reports for the duty without such prescribed mobile phone, then a penalty as mentioned under Liquidated damages shall be imposed.

11. The drivers performing these duties must always be in proper uniform and should always wear shoes.

12. All essential documents such as; valid certificates relating to registration, road-tax, insurance, fitness, permit, PUC etc. (Whatever applicable) should always be available with the vehicle.

13. The vehicle on Seamen's Employment Office, Mumbai Shipping Office Mumbai duties shall be equipped with good condition spare wheel and required tools such as jack, spanner etc. for attending any unforeseen service impediment like tyre getting puncture /damaged etc.

14. The vehicle on Seamen's Employment Office, Mumbai Shipping Office Mumbai duties shall be equipped with First Aid Kit with adequate medicines and fire extinguisher.

15. The vehicles should contain at least two sealed water bottles, tissue box etc.

16. The driver should ensure to get the meter reading checked by the customer while pickup & drop. The duty slips should be properly filled & signed before release.

17. Contractor shall ensure that while the vehicle reports for the day's duty, its fuel tank must be filled up sufficiently for smooth services during the day. 6 / 9

18. Any deficiency in service requirements stated in the contract shall attract penalty as per Liquidated damages clause.

19. It shall be the responsibility of the Contractor to arrange safe and secured parking for his vehicles. During duties and subsequent release, the vehicles shall be parked by the contractor at a designated place / near to Seamen's Employment Office, Mumbai reporting place at his risk & cost.

20. STATUTORY RESPONSIBILITIES OF THE CONTRACTOR: Contractor shall comply with the provisions of all laws, rules and regulations and notifications whether central or state or local, as applicable to him or to his contract from time to time, at his cost.

21. PAYMENT AND BILLING Contractor shall submit the bills on monthly basis for the services provided under the contract. The bills should be submitted by the 1ST week of every month. This shall be scrutinized and checked before passing the bills for payment.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
