If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

All participating bidders must submit the following documents and fulfil the requirements listed below along with the **Technical Bid**:

**Mandatory Documents:**

1. The Bidder/OEM (directly or via reseller) must have successfully executed supply and installation of office Furniture in Government / Semi-Government / PSU / Private Sector / SME within the last three financial year.

2. Site Inspection and demonstration of sample product as per list. All the Bidder should visit the office at Civil Lines, Nagpur on 15 May 2026 between 10.00 to 16.00 Hrs. along with sample furniture and with sample material and as per tender specification.
3. Delivery Period: Within 30 days at the consignee's location.
4. Service Centre: Bidder/OEM must have a functional service centre/ installation cell in the city of the consignee.
5. Escalation Matrix: A list of telephone numbers for service support escalation must be submitted.
6. Blacklisting Declaration: The bidder must submit an undertaking on Letter Head stating the firm has not been blacklisted or debarred by any Government / Semi-Government / PSU / Banks / Universities / Educational Institutions / Autonomous Bodies in the last three financial years.
7. Installation Declaration: Installation work must be carried out directly by the OEM to ensure quality workmanship. A declaration from the OEM is required.
8. Warranty: Products must come with a one-year warranty. An undertaking on company letterhead confirming this must be submitted.
9. Document Validity: All submitted documents must be valid at the time of bid submission. The organization reserves the right to accept or reject any tender without assigning reasons.

## अस्वीकरण/**Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in
