### 1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### 5. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

The procedure for evaluation of tenders shall be as follows:

1. Only the Technical Bid, of those parties uploading their bid with the requisite EMD/EMD Exemption document (As per this tender), along with valid PQC Qualification Documents and submission of Other Mandatory Documents shall be eligible for opening of Price Bids.
2. Bidders are informed that No Reverse Auction (RA) will be conducted for finalizing this Tender.
3. The techno- commercial bid shall be scrutinized and evaluated based on the qualifying parameters mentioned above and on the basis of the uploaded documents in GeM portal. To assist in the scrutiny, evaluation and comparison of bids, IOCL may, at their discretion, request clarifications on the bid from the bidder including submission of additional documents.
4. The Price Bid of only those parties shall be opened who qualify as per the qualifying parameters after evaluation as mentioned above.
5. Bidders are informed that the quoted rate shall be inclusive of applicable GST.

**Following points to be noted:**

- 6. Section-A is estimated value of Job based activities whose cost implication is calculated by considering Minimum wages /fair Wages as released by Govt. valid as on date and hence total price as calculated in the estimate will be treated as Floor Price. Bidders shall not be allowed to reduce prices below the Floor Price. (Refer SOR)**
7. Section-B which includes the service charges of Contractor and Miscellaneous items (item-based activities other than manpower cost) This will be applicable for quoting in bidding process without any limitation. **(Refer SOR)**
8. It may be noted here that payment to the vendors will be made based on actual quantity executed as per SOR.
9. This GEM bid will be created and published with floor price (minimum value, i.e. Fixed Charges) as depicted above.
10. Methodology for determining L-1 bidder:
- 11. Section-A of above table will be limited by floor price, bidders to quote at least equal to or above the floor price,**
- 12. Bidder to quote on Section-B as mentioned in SOR**
13. There is no limitation on the prices offered in Section-B.
14. Final Price offered will be sum of Section A and B and L1 bidder will be determined based on lowest offered price.
- 15. No reverse auction is applicable for this tender as per IOCL policy.**
16. Party who has quoted the lowest rate (L1 rate) on total cost basis, inclusive GST will be considered for award of work with or without negotiation, as per the policy of the Corporation.
17. Negotiations shall not be conducted with the bidders as a matter of routine. However, Corporation reserves the right to conduct negotiations. Tenderers will have to attend the Office of INDIAN OIL CORPORATION LIMITED as informed by Tender Issuing Authority for negotiations/clarifications as required in respect of their quotation without any commitment from INDIAN OIL CORPORATION LIMITED.
- 18. In case of tie between two or more bidders at L1 position, L1 bidder shall be selected as per the GEM Modalities. Refer to the latest GEM General Terms and Conditions document for more details.**
19. In case a bidder is put on holiday / Blacklisted after opening of price bid, then bid of such bidders will be ignored & will not be further evaluated. The bidder will not be considered for issue of order even if the party is the lowest (L1) and BG/EMD made by the party shall be returned. In such situation next lowest shall be considered as L1.

20. Bidders shall submit declaration on proceedings under Insolvency and Bankruptcy Code, 2016. Offer will not be considered of bidder(s) in the following cases: If insolvency resolution process has commenced (viz. application has been admitted by Adjudicating Authority and moratorium has been imposed and IRP has been appointed) or liquidation or bankruptcy proceedings have commenced in respect of bidder in terms of Insolvency and Bankruptcy Code, 2016 or any other applicable law (in cases where code is not applicable) at any stage of evaluation of bid. In case where the bid of the L-1 bidder is rejected on the aforesaid grounds during the period between Price-Bid-Opening and Award of Contract, the bid of the next higher eligible bidder will be considered for further processing. EMD of such bidder shall be returned. Wherever no deviations are desired from specific terms and conditions, bidder's offer shall be rejected, if they take deviations.
21. Document verification with originals shall be carried out after opening of price bids for the short listed bidder(s) only. Since documents are submitted by the bidder(s) in the tender, the responsibility of authenticity of documents shall be with the bidder(s).

Shortlisted bidder(s) shall be required to present their original documents to the tender inviting authority within a period of 7 days from the date of intimation by IOCL.

In the event of failure of such bidder(s) to get the documents verified as per the specified time schedule, the EMD of the bidder(s) shall be forfeited. In case it is observed that if any bidder(s) submitted forged documents / credentials, necessary action for holiday listing of the bidder(s) shall be carried out including forfeiture of EMD.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
