1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small

Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

3. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

4. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

Eligibility Criteria:-

1. The offer against this tender from suppliers to whom LTE has been issued through invitation shall only be considered. Offer from any other party shall be treated as unsolicited.
2. Where dealers are submitting offer on behalf of invited manufacturers, they have to attach valid authorization certificate (bid specific) of invited manufacturer.
3. Whoever, is interested to be registered as a supplier of these items, should fill up the vendor registration form, hosted on the website www.sailtenders.co.in. The normal registration process shall, thereafter, be followed by SAIL-RSP for registering the eligible suppliers. This information is solely for the purpose of exploring the possibility of enhancing vendor base, wherever required and should not be considered as a purchase enquiry. Purchase enquiry in future may be issued to such suppliers, if registered.

SPECIAL TERMS & CONDITIONS:

Approval of Drawings & QAP

The supplier shall submit General Arrangement (GA) Drawings, Bill of Materials (

BOM) and Quality Assurance Plan (QAP) to the Indenting Officer (I/O) for approval prior to commencement of manufacturing within 15 days of placement of order and the indenting officer will give the approval/comments within 10 days of submission of the above documents by the vendor.

Manufacturing shall begin only after written approval of GA Drawing, BOM and QAP.

Drop-in Replacement Requirement

The supplied Gearbox Assembly shall be a drop-in replacement for the existing installed gearboxes without requiring any structural or dimensional modification.

All mounting dimensions, shaft details and coupling interfaces must match the existing setup.

Mandatory Certificates to be Submitted:

The supplier shall submit the following documents along with each gearbox supplied:

- Material Test Certificate (MTC)
- Heat Treatment Certificate
- Guarantee/Warranty Certificate
- Fitment Certificate
- Trial Test Certificate

Quality Assurance Requirements

The approved QAP shall mandatorily include the following:

Leak test of gearbox casing.

Certificate confirming defect-free gearbox casing after testing.

Maintenance & Technical Documentation

Detailed Maintenance Manual, including lubrication schedule, exploded view drawings and spare part list, shall be supplied along with the gearbox.

Bearing Make Specification:

All bearings used in the gearbox assembly shall be strictly of SKF / NTN / FAG make only.

Supplier shall provide bearing make & model confirmation in the BOM.

Packaging Requirement:

Gearbox shall be suitably packed with proper supports and moisture protection to prevent transit damage.

Any damage due to improper packing shall be to the supplier's account.

Inspection:

Inspection shall be carried out by RSP's nominated I/O as per the approved QAP.

Supplier shall provide all facilities for inspection and testing at their works.

Guarantee / Warranty:

The supplier shall guarantee trouble-free performance of the gearbox for a period 12 months from the date of commissioning or 18 months from the date of supply, whichever is earlier.

Defects arising during the guarantee period shall be rectified by the supplier at no extra cost.

Compliance:

All terms specified above shall form an essential part of the Purchase Order.

Any non-compliance may result in rejection of the material.

INSPECTION TERM:

INSPECTION BY MM(INSPECTION),RSP AT THE RSP STORES AGAINST MATERIAL TEST REPORT, FITMENT CERTIFICATE, GUARANTEE CERTIFICATE & TRIAL TEST CERTIFICATE AND RS DRAWING.

GUARANTEE CLAUSE: 12 MONTHS FROM THE DATE OF COMMISSIONING OR 18 MONTHS FROM THE DATE OF SUPPLY, WHICHEVER IS EARLIER.

PRICE VARIATION CLAUSE: FIRM TILL DELIVERY.

DELIVERY REQUIREMENT: ITEMS ARE TO BE DELIVERED WITHIN 150 DAYS OF PO PLACEMENT.

PACKAGING CLAUSE: TO BE SUITABLY PACKED TO AVOID ANY DAMAGE DURING TRANSPORTATION, TRANSIT, HANDLING & STORAGE.

PLACE OF INSPECTION: INSPECTION AT RSP STORES.

INSPECTION AGENCY: BY MM (INSPECTION), SAIL-RSP, ROURKELA.

RPN Clause:

Subject to the terms and conditions of the gem contract, if the supplier neglects or fails to perform the contract by the time or times agreed upon, for any reason other than force majeure, the purchaser after having come to know of such negligence or non-performance, after giving 14 to 30 days' notice to the seller to rectify or such any extended period that the seller and purchaser may mutually agree, shall take such action as it considers fit including but not limited to taking risk purchase action for supply of similar materials, mitigating any losses, at the risk and cost of the supplier as far as the undelivered quantity in that delivery period is concerned. The right of the purchaser for risk purchase action is in addition to the right of purchaser to terminate the contract due to the fault of the supplier. The price differential in case of higher cost to RSP-SAIL, if any, shall have to be borne by the defaulting supplier. RSP reserves the right to recover the price differential from pending bills of the supplier in other sail units. Moreover, the defaulting supplier shall have no claim over the quantity, which they failed to supply.

SAIL-Rourkela Steel Plant (RSP) shall be placing back-up order against gem contracts on successful bidder(s). The concerned bidder has to mention the back-up order number in the invoices for proper accounting of material upon receipt in SAIL-RSP.

Hard copy of the invoice signed and with seal (or digitally signed invoice), has to be sent to manager (F&A), store bills, administration building, Rourkela Steel Plant, Rourkela, Odisha 769011.this will help us in ensuring timely payments.

SAIL-RSP is entitled to claim credit of input tax (ITC) paid on the supply of the bid item (as applicable). Since BOQ bidding in GeM does not provide for calculation of ITC amount from back-end, the basic prices will be arrived at, by back-calculation from quoted rates, considering the GSTs applicable.

Any attachments in the bids, which are at variance from the above terms & other terms & conditions of this bid shall be ignored and the firm shall be evaluated on based the terms of this bid only.

Bidders must submit a "self-declaration certificate" mentioning that all terms and conditions of the tender are acceptable to him/her. Bidder(s) is not required to upload the signed copy of the bid/RFQ again.

4. Bidders are requested to submit certificate of LOCAL content in the item to justify the MII eligibility.
5. Bidders are requested to submit required documents supporting eligibility criteria.
6. Bidders are requested to submit all supporting documents and clarification reply in GEM portal within 3 days of communication failing which the offers of the bidders shall be evaluated based on available documents without any further communication.
