1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Security deposit clause: The Security Deposit for faithful performance of the contract has to be furnished by every successful tenderer. No exemption will be made. The scale of Security Deposit to be furnished is as under:

5.00% of the basic contract Value. The security deposit shall be valid for a period of one year (Contract Period) plus two months. The contractor will have to furnish Security Deposit within 14 days of award of the contract as specified in the tender in the form of either a Demand Draft in favour of Rashtriya Chemicals and Fertilizers Ltd. payable at Mumbai, or by means of Bank Guarantee as per RCF's proforma (attached as Annexure-VI), from listed Nationalised/Scheduled Bank. The Security Deposit shall be furnished to RCF, for a suitable period as prescribed by RCF in the tender. The Bank Guarantee should be forwarded by the Contractor's Banker's directly to RCF with the covering letter of the bank.

Failing to submit security deposit/Bank Guarantee within 14 days of receipt of work order/LOI, necessary action of forfeiture of EMD will be taken against the contractor.

Refund of Security Deposit: On due satisfactory completion of the contract in all respects, the Security Deposit will be refunded to the Contractor without any interest.

2. Earnest Money Deposit: ₹ 3,00,000.00

Bidders are required to deposit an EMD of Rs. 3,00,000/- in the first instant itself at the time of offer submission only in the concerned packet. Any offer without EMD shall be treated as non-responsive offer and shall be rejected summarily. No correspondence in this regard shall be entertained. For paying EMD, please log on to <http://www.rcftd.com> and then go to 'portal' and 'EMD' payments'. Kindly use the GEM enquiry number on the portal for EMD payment. Please submit EMD payment receipt along with the offer. EMD payment by any other mode may not be considered.

If for any reason whatsoever any tenderer withdraws the tender at any time prior to expiry of the validity period or after issue of the letter of intent, purchase order, fails or refuses to execute the order or to furnish the security deposit for faithful performance of the contract within 14 days from the date of purchase order then, amount of earnest money is liable to be forfeited.

EMD in the form of Demand Draft or any other form will not be accepted. Offers without EMD (or) valid NSIC/MSE certificate (Refer Annexure-XIII) are liable to be rejected.

2.1 Earnest Money Deposit should be furnished as per above Terms and conditions

2.2 Any request to adjust Earnest Money Deposit out of the tenderer's running bills or pending

ng payments will not be considered and the Tender will be treated as without Earnest Money Deposit.

- 2.3** Tenders received without Earnest Money Deposit or with the Earnest Money Deposit in a manner other than what is mentioned above will not be accepted.
- 2.4** Govt. of India Undertaking and small-scale industries registered under single point registration with national small-scale Industries Corporation are exempted from the payment of Earnest Money Deposit.
- 2.5** Forfeiture of Earnest Money Deposit: If for any reason whatsoever any tenderer withdraws his tender at any time prior to expiry of the validity period or after issue of the Letter of Intent, Work Order, fails or refuses to execute the order or to furnish the Security Deposit for faithful performance of the Contract within the stipulated time the amount of Earnest Money Deposit is liable to be forfeited.
- 2.6** Refund of Earnest Money: Earnest Money Deposit will not carry any interest. Earnest Money Deposited by the unsuccessful tenderers will be refunded as soon as possible. Earnest Money Deposit of successful tenderers will be refunded after the successful tenderer furnishes the required Security Deposit.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
