In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. Special terms and conditions-Version:1 effective from 11-06-2025 for category Water Vending Machine / Water ATM Machine

1. Standard Terms and Conditions for Water ATM / Water Vending Machine

Buyer's Responsibilities:

1. To provide all necessary clearances from the civic authorities about the clearances of all the sites wherein the freestanding structure / rigid structure needs to be installed.
2. ATM Encloser / Layout
 - a. Buyers should provide an approved civil layout / detailed drawings rigid encloser / Water ATM room encloser / Water Piayu room. The maximum size of the rigid encloser / water ATM room shall be 10ft (H) X 10ft (W) X 10ft(D) suitable for housing all required plant and machinery of the water ATM. (the complete civil works as per approved drawings is under the sellers' scope of work and supervision and testing of civil works is under buyers' scope of works)
 - b. Buyers should provide approved layout and proper flat-level, duly cemented or with proper civil works suitable for installing the freestanding Water ATM Encloser and all required plant and machinery of the water ATM. (the complete civil works as per approved layout is under the buyers' scope of work)
3. To provide gate passes for the installation team to access the area where installation to be carried out.
4. To provide suitable electrical power / DG Set power to run the machine.
5. To provide potable water of reasonable quality without having muddy appearance, solids and waste etc. The input water is usually supplied by local municipalities or PHED supplies.
6. The Input water Head (pressure) shall be 0.3 kg (3-meter head) in case water ATM without Inlet Storage Tank.

Seller's Responsibilities:

1. To ensure necessary and trained manpower is deployed at the site for installation of the machine.
2. To ensure all the required tools and machinery as required for installation and commissioning of machines.
3. To ensure all the water connections are neatly done so to avoid any leakages during operation.
4. To ensure that all electric parts are suitably insulated and earthed to avoid electric shock during usage.
5. To provide all the relevant documentation for RTO registration of Built Up vehicles (applicable for Mobile ATM machines)
6. During the comprehensive warranty period or CMC Period.
 - a. Seller should ensure necessary visits of their technical personnels to carryout necessary service as per the defined OEM's SOP. Changing of pre-filter during each visit or as per the defined OEM's SOP.
 - b. Complete cleaning of the machine along - with water tanks on each visit
 - c. Changing complete Filters once a year free of cost which may include but not limited to Sand Filter, Sediment Filter, Carbon Filter, Mineral Filter, Micron Filter, Anti-Scaling, Alkaline Filter, Flushing Mechanism, Reject Water Control Mechanism, Mineralizer/Taste Enhancer Media, Activated Carbon Media, etc. (as applicable).

Note to Seller's:

1. Seller may refer to GTC and ensure strict compliance with the uploaded/ offered product which shall be in line with their model having the claimed specifications in the catalogue or better.
2. In case any discrepancy is observed in the offered/ uploaded products, OEM dashboard of the

respective Brand may be removed, and account shall be suspended as per IM policy.

Note to Buyer's:

1. Buyers should also refer to GTC Clause 4. xiii.(w). The ATC / additional specification if any added by the buyer shall not be contradictory to the GeM category specifications / technical parameters (TP). OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. After award of contract - Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing- the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. **Generic**

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

5. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

6. **Certificates**

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working

Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
