Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1). Scope: The hired vehicle/vehicle's will have to perform all the work of transportation as per bid under consignee XEN Bridge Line NGP to and from and also as and when required, including Sunday and holidays as notified by the Railway Administration from time to time at the discretion of Railway. If vehicle service type in contract is outstation 24x7 no additional charges for extra hours are payable. In case of 24x7 vehicles, as per GeM, finite hours mentioned will be treated as null and void.

2). In case of any conflict between GeM standard tender condition and special condition added by buyer, special condition added by buyer will prevail over standard GeM condition.

3). Payment terms/Invoice creation by service provider:

i. Calculation of Running charges for invoice creation:

5). Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the contract or any part thereof by a written notice to the Seller, if:

- (i) The seller fails to comply with any material term of the contract.
- (ii) The Seller informs Buyer of its inability to deliver the Material(s)/service or any part thereof within the stipulated delivery period or such inability otherwise becomes apparent.
- (iii) The Seller fails to deliver the Material(s)/Service or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s)/Service promptly.
- (iv) The Seller becomes bankrupt or goes into liquidation.
- (v) The Seller makes a general assignment for the benefit of creditors.

(vi) A receiver is appointed for any substantial property owned by the Seller.

(vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

6). Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt.

7). Service & Support AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the State of Consignee (or area of usage: MP/CG/MH). DOCUMENTARY EVIDENCE TO BE SUBMITTED (i.e. MSE certificate, UDM, Udyam, Gumasta, GST certificate, PAN card of firm etc). (Self Declaration/Kirayanama will not be considered).

8). PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries/wages of contracted staff deployed at buyer location as per pertaining labor laws.

9). Bidders can also submit the EMD @2% of Estimated value of Bid with Fixed Deposit Receipt made out or pledged in the name of PFA SECR BILASPUR A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favor of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/Bid Opening date. 10). Successful Bidder can submit the Performance Security @5% of contract value in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of PFA SECR BILASPUR A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favor of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 30 days of award of contract to Office of buyer. Delay of submission in penalty will be dealt as per GCC services upto latest correction slip.

11). The Purchaser reserves the right to increase the quantity (number of months of operation) to be ordered up to 25 percent at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity (number of months of operation) during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

12). Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard. GST reimbursement will be as per actual or as per applicable rates (whichever is lower) subject to the maximum of quoted GST %

13). Vehicle should be registered in the name of Tenderer and should not sublet any part of the contract. However, the Tenderer can have Lease Agreement with the owner of the vehicle/cab aggregator on non-judicial stamp paper for the tenure of the contract, which should be submitted along with the bid. The Tenderer is required to submit the Vehicle registration details along with supporting documents of the vehicle fulfilling the category, specifications etc.

14). It should be stipulated that the vehicle supplied should be registered as Taxi/Goods carrier as applicable for bid. Bids of vehicle other than commercial vehicles should be summarily rejected. It should have "Valid Fitness certificate commercial license" (Permit for Commercial Vehicles shall cover all States in S.E.C. Railway jurisdiction or as considered necessary by the Department/Division/Unit calling the tender from the appropriate Regional Road Transport Authority of the concerned State Govt./Union Territory), valid insurance and should meet requirements of pollution standard etc. as per provisions of Motor Vehicle Act and fulfil any other statutory obligations as applicable including all safety approved accessories/equipment fitted to the vehicle. Driver should possess a valid driving license, Aadhar Card on his name and employee identification card issued by the

Contractor at all times. The documents shall be verified by using official before passage of each bill .

15). The vehicle proposed to be offered on hire should be in good condition and model of vehicle shall be as per bid.

16). All hired vehicles should be equipped with prescribed emergency medical kit and a fire extinguisher as per statutory provisions.

17). The vehicle should be available on all days including holidays.

18). PVC is not applicable to the tender.

19). A Log Book for each vehicle shall be maintained by the Contractor for the hired vehicles. The KM utilized shall be entered in it on a daily basis to ensure proper account and payment at the end of every month/specified period.

20). One weekly off is permitted to the driver normally on Sundays however it may be deferred to some other day at the discretion of the user/officer in charge to whom the vehicle is attached.

21). Normal working hours may be advised by the user department however the vehicle shall be available for all 24 hours for use as and when required. The driver of the vehicle shall keep himself in contact with the user/officer in charge.

22). The vehicle supplied should be neat, clean and in good fettle. The driver must be well dressed and in white or grey uniform.

23). Mobile phone should be provided to the vehicle driver with a smart handset (24x7). The driver of the vehicle shall keep himself in contact with the user/officer in charge.

24). As and when required by user/officers, vehicles can also be utilized for travelling outstation i.e. more than 50 Km.

25). Vehicle required to be parked at office/user premises.

26). Vehicle must have a minimum 200 km range 12 Litres equivalent fuel available on each service providing a day to avoid service interruption. Failing to above condition will be treated as not a availability of services and to be dealt as per the existing penalty clause available in GEM i.e. SLA clause No. 8(7) of GeM contract/Special conditions of contract.

27). The contract will also be governed by GeM SLA, Buyer specific Bid ATC, Railways GCC of service contract as amended from time to time by the Railway Board.

28). The vehicle provided will meet the latest government standards for safety and pollution i.e. minimum 5-6 or Bharat Stage VI or latest applicable or any other rules/provisions as issued by state/central government.

29). The service provider shall comply with all rules & regulations issued by state/central government from time to time, applicable to this contract.

30). Penalty clauses applicable as per GeM SLA of Bid.

31). On reasons considered beyond administrative control of buyer, upon intimation of User/Consignee, buyer reserves the right to terminate full/part of contract without consent of seller by giving 7 days notice to firm (Transfer of official, vacancy of post, FMC etc).

- d). If vehicle is changed during contract period then official communication made from contractor to user with all relevant papers is available. The changed vehicle is in the same segment as specified in agreement.

Before forwarding vehicle bill to accounts department for internal check the above points to be invariably complied by executive department.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless

otherwise allowed by the applicable GeM GTC.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
