4. Manufacturer Authorization: The bidder (Authorized Agent) has to submit Bid Specific Authorization from the Manufacturer.

5. Security Deposit: The bidder has to submit Security Deposit for an amount equal to 5% of the value of GeM Contract. The e-PBG mentioned in the bid is to be treated as security deposit.
