1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. 2. "Color family" is indicative in nature and to be considered for representative purposes. Seller to select the closest representative color from the given options.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 7) Reseller/ bidder must submit manufacturer's authorization letter in favor of bidder/ tenderer from the manufacturers of the products. BID specific authorization contact details of OEM mentioned in Authorization certificate, it will be cross check by its OEM.
- 8) Bidder/OEM must have a registered office and service center in ODISHA.
- 9) Escalation Matrix for Service Support: Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 10) Terms & Condition Acceptance Certificate should be submitted
- 11) Bidder/OEM must upload Datasheet of offered products (Picture/Drawing, Make and Model) should be uploaded and submitted along with bid compliance documents for technical evaluation.
- 12) Tenderer must have experience of supply of furniture items in any Central/State Govt. departments, PSUs of Central/State Govt. and Institutions within India. Documentary evidence to submit.
- 13) The Turnover Certificates on CA Letter Head with UDIN number to be submitted along with the Bid Documents.
- 14) All the OEM of offered product is must be certified as per the required certification mentioned in specifications like BIFMA, GRIAH, AIOTA, GREEN PRO, GREEN GUARD, ISO9001-2015, ISO14001-2015, ISO 45001-2018
- 15) OEM should have 30 yrs more experience proof of same must be uploaded.
- 16) The bidder/seller must not have been blacklisted by any government offices, societies, authorities (State Government or Government of India), PSU (Publ

ic Sector Undertakings), or government-run autonomous bodies or societies in India for corrupt, fraudulent, or any other unethical business practices, or for any other reasons. To comply with this requirement, the firm must submit a Notary Affidavit on Non-Judicial Stamp Paper (Rs. 100/-), clearly mentioning the BID number.

17) Product shall be provided as per specification as mentioned in tender. Bidder shall enclose No Deviation Certificate as mentioned.

18) The authority reserves the right to cancel the bid at any point of time without assigning any particular reasons thereof.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
