3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Scope of Work: Digitize approx. 95000 documents of various size, ensuring high quality scanning, image processing and metadata creation as per standards and carry out quality control as per the output specifications. 3. Input specification/Materials/data (a) The documents to be digitised is A most of the documents are sizes such as Legal , A3, A-4, A-5. (b) Records are old, fragile, deteriorating, rare and brittle and are to handle with great care. (d) Some of the pages of the records have stain-marks and worm-marks. (e) The pages of some records have become translucent due to ageing. (f) Bleeding of ink on the reverse of the page may be seen in some records . 4. Job specification: (a) Documents Copying/Image Capturing (Scanning) (i) The records should be digitized at minimum of 1200 dpi in true optical resolution using Face up Scanning technology with pixel type moving linear CCD sensor overhead scanner or a Metamorphaze and FADGI image quality guidelines compliant Area CMOS overhead scanner in the 24 bitcolour mode specs or 8 bit grayscale to capture original information. Specifically, text documents are to be scanned at minimum 1200 dpi. (ii) All the digital images should have a checksum for the authenticity of digital image. (iii) Scanner should use cold light with such intensity of light during scanning so that it does not damage the fibres. of the aging pages or prevent any harm to the original records and uniform illumination at the time of capture. The scanner must be capable to lightly control nonlinearities and quantization noise for handling records of variable density and achieving optimized results for all types of records. (iv) Coloured charts, diagrams, photos, illustration etc. are to be scanned separately whenever applicable.

(b) Image processing and cleaning (Image Enhancement): (i) The TIFF images will have to be further enhanced to increase the legibility of the text and overall visual appeal of the document without altering the authenticity of the original source. (ii) Image enhancement activities to be carried out to remove bleed through, black border removal, curvature correction, light equalization, brightness and contrast enhancement, denoising , de-skew and despeckling, cropping. cleaning, sharpness, focus enhancement, background removal for text areas without violating content in picture zones and without altering the original capture dpi. (iii) ) The removal of digital noise will include removal of worm-marks and stain- marks to the maximum possible extent, while keeping the colour information intact. This component of digital restoration will aim at attaining a relatively high level of noise-free state of the digital images. (iv) Resizing of every images with do skew, rotate, height-width, margin, etc. to make every image perfect and uniform in size. (v) Proper editing has to be done to the images to straighten the orientation of the content matter if there is any disorientation existing in the pages .(vi) 100% manual operator assisted quality check to be performed on every image to ensure there are no missing or dropped pages & images are optimized to their optimum levels. Perform quality checking of every digitized image pages. A detailed OC list has to be generated for every page being processed in the project. (vii) Nuances in the document such as notes, remarks, and pencil marks are of historical value and they must be presented in such a way that may be referred in lieu of the original document. (viii) Image processing will follow a general priority guideline of legibility, aesthetics and file size in that order. (ix) For each document, a thumbnail image should also be generated. (x) The enhanced images will have to be delivered in the JPEG v1 .02 Format (ISO DIS 10918-1/ISO/IEC10918-5:2013). (xi) The vendor will not carry the above exercise outside the premises of CAM for any reason . (C) Proofreading of Digitized Content □ The vendor must carry out comprehensive proofreading of all digitized pages to ensure that: o All text appearing in the scanned images is clear, legible, and correctly represented. o No content has been inadvertently cropped, distorted, or lost during image enhancement or processing. o Page numbers , headers, footers, notes, and marginalia remain accurate and intact.

□ Proofreading must ensure that: o The sequence of content matches the physical documents. o Text alignment and readability are consistent across the entire document set. o Any anomalies such as missing characters, blurred text, or alignment issues are flagged and corrected. □ A Proofreading Verification Report must be prepared for each batch, including: o Pages reviewed o Issues identified o Corrective actions taken o Final approval status □ Proofreading must be conducted manually by trained operators, with 100% verification before final image approval.
