### 1. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

The tendering service provider are required to upload attested copies of the following documents (duly self - attested) on the GEM Portal, failing which their bids shall be summarily rejected and will not be considered any further and bid will be treated as non - responsive.

- The number of days for booking of vehicle shown in the contract are tentative and can be increased or decreased as per requirement of office and there will be no limit of minimum or maximum booking during the contract period. The vehicle will be booked on 'As and When Required' basis as per the requirement of office.**
- AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the service provider must be located in the District of Ahilyanagar (Ahmednagar). DOCUMENTARY EVIDENCE TO BE SUBMITTED.**
- Office of the Service Provider / Bidders is required to be in the District of Ahilyanagar for better coordination, smooth service and other administrative factors. Registered Office address on **MSME Certificate, GST registration should have address of Ahilyanagar (Ahmednagar) District** and same shall be verified and accepted as registered Office address proof. Bidder registered office shown on the documentary proof such as electricity bill (in the name of firm) or registered agreement from sub registrar office Maharashtra state will also be accepted as a proof of registration certificate for Geographical presence. Documents referred above will only be considered as a proof of registration certificate for Geographical presence. **(Notary agreement made on Rs.100/500 on non -judicial stamp will not be accepted).**
- GST Registration Certificate.
- Undertaking on the letter head of firm stating that the **firm is not debarred/blacklisted/ suspended/ banned by any Government/ Public Sector undertaking/ Corporate Organization or convicted in any court of law across India or declared bankrupt or insolvent during the past years, in any manner** should be submitted afresh addressing to the "The Deputy Director General(E), Akashvani, Pune.
- Bidder's offer is liable to be rejected if they don't upload any of the certificate

/documents sought in the Bid document, ATC and Corrigendum, if any.

7. **BIDDER FINANCIAL STANDING:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.
8. Duration of the service contract may be extended up to 3 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
9. If performance of services is not satisfactory or for any other administrative reasons the contract can be cancelled by giving 30 days notice to the agency.

Note:

- (i) All firms have mandatorily to submit the certificate(s) for above points falling which they will not be considered for financial bid.
- (ii) **Only relevant documents are to be uploaded under a particular tab like Experience Criteria, Bidder Turnover, Certificate (Required in ATC), Registration Certificate for Geographical Presence as required by Buyer, etc. In case of uploading irrelevant documents or uploading the same set of documents under each tab, the bid shall be rejected.**

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
