1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its

subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. ### 1. Submission of Price Elements:

Bidders must submit all price-related information exclusively in the *Financial Bid*. Any mention of price elements in the *Technical Bid* will render the offer non-responsive and liable for rejection, except in the case of **Single Packet Bidding**.

### 2. Eligibility Criteria for Bidders:

The bidder must be one of the following:

- The manufacturer,
- A 100% subsidiary of a foreign manufacturer operating in India,
- The sole authorized distributor of the manufacturer, or
- A direct authorized distributor of the manufacturer.

*Note:* Sub-authorization (i.e., authorization granted by an intermediary rather than the manufacturer) will not be accepted.

### 3. Submission of Manufacturer Authorization:

Where authorized distributors submit the bid, a bid-specific, valid Authorization Form/Certificate from the OEM must be furnished along with the bid. This document should include OEM details such as name, designation, address, email ID, and phone number. Failure to provide this will result in summary rejection of the offer.

4. The requirement given in instant Bid is of Proprietary Nature and only OEM i.e. M/s. Azooka Labs Private Limited or its authorized partners are eligible to quote for this bid. Bids without Manufacturer Authorization Form from M/s. Azooka Labs Private Limited will not be considered and will be summarily rejected.
