### 1. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 2. Buyer Added Bid Specific ATC

#### **SCOPE OF WORK:**

1. **Providing of 01(one) no. Brand new vehicle (Mahindra- Bolero or equivalent) for TAWANG off ice for execution of work under Comp T&D Scheme of Arunachal Pradesh for a period of 2(two) years with commercial permit for Arunachal Pradesh & Assam** along with driver, all consumables including lubricants tools & tackles, spares and uniform of driver, at the cost of the contractor. **The Contract period may be extended for maximum period of 01(One) Year or part thereof, subject to satisfactory performance of the contract.**

2. **Bidders are required to quote the final amount for monthly hiring charges including Driver's wages (Incl. GST) in GeM portal**

**4. Bidder shall not upload the price details in technical part, otherwise its technical bid will be liable to be rejected.**

6. Bidder shall have to fill and upload the following forms along with their bid: (i) EMD/Bid Security (in Original) or Online Payment Acknowledgement towards bid security or documentary evidence in support of exemption of EMD/Bid Security-Mandatory Requirement. Bidder may note that non-submission of Bid Security / documentary evidence for exemption shall lead to outright rejection of their Bid.

(ii) Information regarding Ex-Employees of POWERGRID in our organization (Refer Form No. 1 attached under buyer added ATC).

(iii) Certificate from the Service Provider regarding the percentage of the local content and the details of locations at which the local value addition is made- (Refer Form No. 2 attached under buyer added ATC)

(iv) Bidders are required to meet the Qualification Requirements in accordance with ANNEX URE-QR attached in the bid.

5. The vehicle shall be registered in the name of the person/agency on whom the order shall be placed in the event of award

6. The vehicle shall have valid commercial permit/ registration at the time of deployment. Vehicle having private registration shall not be accepted under any circumstances.

7. Bidders are requested to go through bidding documents along with buyer uploaded ATC before quoting.

8. EMD exemption and purchase preference benefits shall not be extended to such MSE bidders who are **T RADERS**, in line with GeM procedures/policies.

9. The duration of the Contract shall be for a fixed a period of 02(two) years from the effective date of the contract. However, the Contract period may be extended for maximum period of 01(One) Year or part thereof, subject to satisfactory performance of the contract and further subject to requirement of POWERGRID, at the same rate and terms & conditions.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
