3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

1. Scope of Supply

The bidder shall supply, deliver, install, test and commission Automated Attendant Controlled Powered Wheelchairs strictly as per the technical specification mentioned in the tender document.

2. Compliance Requirement

1. The offered product must fully comply with the technical specifications mentioned in the tender.

2. The bidder shall submit a detailed compliance sheet clearly mentioning:

o Specification asked

o Specification offered

o Page number reference of catalogue/brochure

3. Incomplete compliance documents may lead to rejection.

3. Certification & Quality Standards

1. The product must be manufactured under ISO certified facility.

2. Valid CE Certificate for powered wheelchair must be submitted.

3. If applicable, BIS certification or equivalent quality certification to be enclosed.

4. Product catalogue with model number must be attached.

5. Test certificate for braking system and battery safety to be provided.

4. Warranty

1. Minimum 1 Year comprehensive onsite warranty from date of installation.

2. Battery warranty minimum 6 months.

3. During warranty period, all spare parts including controller, motor, battery and braking system shall be replaced free of cost in case of manufacturing defect.

4. Complaint must be attended within 48 hours.

5. Installation & Demonstration

1. Supplier shall deliver the wheelchair at consignee location.

2. Demonstration and basic operational training shall be provided to staff.

3. Installation report duly signed by consignee shall be submitted.

6. Delivery Schedule

1. Delivery shall be completed within the period mentioned in the Purchase Order.

2. Delayed delivery will attract LD penalty as per government norms.

7. After Sales Support

1. Bidder must have service support facility in Karnataka.

2. Service contact details must be mentioned in the bid.

3. Availability of spare parts for minimum 5 years shall be assured.

8. Packing & Transportation

1. Proper industrial packing must be ensured to avoid transit damage.

2. Any damage during transportation shall be replaced at supplier's cost.

9. Price Conditions

1. Price quoted shall be inclusive of all taxes, packing, forwarding, freight, insurance, installation and commissioning.

2. No extra charges shall be entertained after award of contract.

10. Payment Terms

1. Payment shall be made after successful delivery and installation.

2. Necessary documents such as Invoice, Warranty Certificate and Installation Report must be submitted.

11. Rejection Clause

1. Any deviation from specification without prior approval shall lead to rejection.
2. Substandard or non-compliant product will be returned at supplier's risk and cost.
