PART I: GENERAL INFORMATION

1. The bidders are instructed to quote specific make, model and other relevant details for items for which rates are quoted, irrespective of whether specifications are mentioned by the make/model or not.
2. OEM/Authorized dealer certificate is to be uploaded along with this bid and ISO 9001 (Quality and Safety), 9000 (Quality Mgt) to be submitted at the time of submission of technical bid.
3. **Fall Clause:** The price charged for the stores supplied under the contract by the contractor or shall in no event exceed the lowest prices at which the contractor sells the stores or shall to sell stores of identical description to any persons/Organization including the contractor or any department of the Central Government or any Department of state Government or any statutory undertaking the central or state government as the case may be for a period till performance of all supply orders placed during the currency of the contract is completed.
4. **Terms & Conditions of Delivery Period:** Delivery period for supply of items shall be 5 days from date of placing GeM contract **at Khalsar, Nubra Valley, Ladakh (consignee loc)** and all the goods in the GeM shall be offered on free delivery at site basis including loading, unloading and certificate confirming the same need to be enclosed with the bid. **Bidders are required to furnish acceptance letter stating that consignment will be delivered at Khalsar, Nubra Valley, Ladakh (consignee loc) within 5 days from date of placement of SO and that no extension period will be allowed to deliver the stores.**

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions stipulated in General Terms and Conditions.

While participating in this tender, the bidder shall undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the applicable law.
