If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 2. Wherever clause of GEM is silent for any modification / alteration, termination, then clause of GCC IR 20 18 or latest for services will be applicable.
3. If any dispute / contradiction arises between condition of GEM and Scope of work/Special condition uploaded then condition of Scope of work/Special condition will be applicable.
4. Bidder must have Years of Past Experience in " Provided Any kind of vehicle".
5. No additional documents submitted by bidders and any modification / alteration / addition / deletion in their re-presentation will be accepted.
6. Bidders are advised to read all the terms & conditions of bid and documents uploaded along with bid.
7. The vehicle so offered shall not be older than year 2024 and should not have travelled more than 25000 km from the date of opening of Tender (Mandatory).
8. All other conditions will remain as per Special condition attached under the bid.
9. Vehicles are required for Deputy Chief Engineer (Construction)-II Western Railway, Ratlam at Ratlam station under the jurisdiction of Deputy Chief Engineer (Construction) I-Ratlam, Western Railway

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
