6. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. **1. Generic**

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

**2. Buyer Added Bid Specific ATC**

#### Buyer Added text based ATC clauses

1. Calibration certificate along with traceability is required for the equipment to be calibrated.

**This entire process, including dismantling and reinstallation, shall be carried out by the authorized service provider at CPRI, Noida Laboratory, to ensure proper alignment, integration, and reliable functioning of the photometric test setups.**

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
