1. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority : Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100 % of total quantity as defined/ decided in relevant policy.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A) Pre-Qualification Criteria:

1. Bidder shall submit credentials as follows:

a) Intending bidders should upload legible scan copy of the credentials of a similar nature of completed work of the minimum value of 30% (Thirty percent) of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice;

Or,

b) Intending bidders should upload legible scan copy of the credentials of 2(two) similar nature of completed work, each of the minimum value of 25% (Twenty Five percent) of the estimated amount put to tender during 5(five) years prior to the date of issue of the tender notice;

Or,

c) Intending bidders should upload legible scan copy of the credentials of one single running work of similar nature which has been completed to the extent of 75%(Seventy five percent) or more and value of which is not less than the desired value at (a) above;

In case of running supply, only those bidders who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no penal action has been initiated against the executing agency, i.e., the bidder.

2. Credential certificate issued by Executive engineer or equivalent or competent authority of a State/Central Government, State/Central Government undertaking, Statutory/Autonomous bodies constituted under the Central/State statute, on the executed value of completed/running work will be taken as credential.

3. Similar supply means the material used as larvicide.

4. Payment Certificate OR GeM Contract will not be treated as credential. In case of GeM supply, **CRAC MUST BE SUBMITTED along with Contract.**

5. Manufacturers of Temephos 50% EC may also participate in the tender with necessary clearance of CIB&RC, but the concerned bidder must submit a clinching evidence showing that it produces Temephos 50% EC by using Temephos Technical procured from any one of CIB&RC-approved indigenous manufacturers of Temephos Technical.

6. A declaration in the form of an affidavit on stamp paper of Rs. 10/-, duly attested by a Notary should be submitted as per format given in the **Pro-forma I**, stating that the applicant is not debarred / de-listed /blacklisted by any Govt. /Govt. Undertaking/ Statutory Bodies established by an act of central or state government/ Municipal bodies at the time of submission of bid..

7. The offered product must have **NVBDCP approved.**

8. Bidder must submit proof of Technical Source (CIB approved) of the tendered item.

9. BIS Certification is mandatory.

10. CIB registration for use of the product for public health is mandatory.

11. In case of reseller, BID Specific OEM Authorization Certificate is mandatory.

12. Materials will have to be delivered in any premises or stores within the jurisdiction of Kolkata Municipal Corporation.

B) Other terms & conditions:

1. If any material is found defective after supply, the same is to be replaced by the seller free of cost within a stipulated time.
2. Quoted price should include all statutory payments imposed by State & Central Govt. Escalation of Price on any ground and consequent cost overrun shall not be entertained under any circumstances. Rates should be quoted accordingly. The bidder has to submit the breakups if asked for.
3. Participating firms must submit a declaration as per the attached Format that they comply with all the terms and condition of the Bid.
4. The bid for procurement of TEMEPHOS 50% EC may be cancelled at any point of time without showing any reason to the bidders.
5. **Shelf life: Shelf life of the supplied material should be 2 years from the date of supply of goods at consignee location.**
6. The supplier has to abide by all terms & conditions of the bid.
7. **Conditional/Incomplete bid will not be accepted under any circumstances. UNNECESSARY DOCUMENTS MUST NOT BE UPLOADED AS IT CONSUMES VALUABLE TIMING DURING EVALUATION.**
8. Bidder shall upload legible scan copy of valid PAN issued by IT Department, Govt. Of India, valid 15-digit Goods and Services tax payer Identification Number (GSTIN) under GST Act, 2017, ITR & BALANCE SHEET for last 2years, latest Professional Tax returns copy and certificate. Trade license will be mandatory for those whose unit is located within the jurisdiction of KMC. **Signed copy of ATC is to be mandatorily uploaded as a testimony of acceptance of all terms & conditions put up in the Bid document.**
9. Successful bidder must submit material Test Report from NABL accredited laboratory at the time of delivering the consignment. However, if the department feels the need of testing the material again, the bidder shall bear the expenses incurred on the testing.
10. The Department may receive the ordered quantity in phases, if required. The same will be communicated through mail after placing the contract.

The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
