Bidders must meet the following criteria:

1. If the bidder is not an Original Equipment Manufacturer (OEM), he should provide the valid authorization certificate from OEM showing his confirmation to extend the maintenance and repair support during Warranty. The quotation without this authorization shall be rejected.
2. Vendor shall provide details of after sales, service and maintenance facilities in India to support warranty and repair of the item along with the quote.

### **Bid Evaluation Criteria**

Bids will be evaluated based on the following criteria

1. The vendor should clearly specify name of the OEM of the item along with its model number and provide product literature with the offer. Specifications of the products offered should be verifiable from web site of the OEM, otherwise the quotation will not be considered valid.
2. Detailed compliance table shall be attached with quote, without compliance offer is liable for rejection. "Complied" or "provided" written against our required specifications will not be acceptable under any circumstances. Compliance table is provided with this Bid specifications. Compliance table shall be duly signed by authorized signatory with company seal.
