OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

Tender Terms and Conditions

1. Interested bidders are required to follow the instructions given on GEM to participate in this e-tender.
2. If the bidders do not submit the items as per the terms and conditions contained in the tender within the stipulated time, their tender will be declared invalid.
3. The tenderer whose tender is accepted will be issued a supply order by this office.
4. Attested (true copy) of PAN card and Income Tax Return for the year 2023-2024 and 2024-2025 are required.
5. The bidder must attach an attested (true copy) of his GST registration certificate.
6. If the bidder is not a manufacturer, attach a letter from the manufacturer whose product he is an authorized dealer.
7. If the bidder is a Micro, Small and Medium Enterprise (MSME), then an updated copy of the certificate of the competent authority should be attached.
8. If the bidder or manufacturer has previously supplied such materials to government or semi-government offices/institutions, copies of their orders should be attached.
9. The bidder or manufacturer should have at least 3 years of experience in supplying government work.
10. It will be mandatory for the bidder to submit an affidavit on a stamp paper of Rs. 500/- that he is not included in the blacklist of any government department.
11. The bidder should have an annual turnover certificate from a CA and an average total annual turnover of one crore in the years 2024-25, 2025-26. OR, the solvency of a nationalized bank (BANK SOLVENCY CERTIFICATE) should be Rs. One crore
12. The right to approve or reject the tender is reserved at the level of this office.
13. The quantity in the tender is estimated and the number of materials to be supplied may be less or more and the provisions may be reduced or increased accordingly.
14. The materials will have to be supplied as per the specifications in the tender. Similarly, if the materials supplied are not found to be in good condition, they will have to be returned at their own expense and no complaint will be entertained regarding this.
15. The average total annual turnover of the tenderer for the years 2024-25 and 2025-26 should be one crore.
16. All certificates should be valid on the date of issuance of the bid. All documents to be attached by the tenderer along with the technical specification and price specification should be attached in Marathi, Hindi, English, as per the requirement. Documents in other regional languages will not be accepted.
17. If there is any defect in the materials supplied by the tenderer within 1 years, it should be repaired as soon as possible.
18. The tenderer shall be required to submit an affidavit stating that all the documents submitted in the tender are genuine and that legal action will be taken against the concerned party and the tender of the concerned party will be cancelled at any stage if the documents submitted are found to be false. An affidavit on a stamp paper of Rs. 500/- will be mandatory.
19. The tenderer shall be required to submit an annual average turnover certificate
20. It is mandatory to attach an affidavit stating that all the terms and conditions of the tender are acceptable along with the bid number and signature.
21. In case of any defect in the warranty period, the supplier shall be required to repair the material. Conditional tenders shall not be accepted.
22. In case of any dispute regarding the terms and conditions of the tender, the decision of this office shall be final and binding on the tenderer.
23. If the tenderer finds the said documents fabricated or incorrect, legal action will be taken against them and they shall be included in the black list.

24. The right to change/cancel the quantity and amount of materials and the tender is reserved at the level of this office.

25. While participating in the e-tendering process, before submitting the tender, the sample of the materials to be supplied should be submitted to Range forest office Sirsi -581401 before 23-02-2026 and its receipt should be uploaded in the bid document.

26. A certificate stating that the sample of the materials supplied is of good quality should be obtained from the Assistant Conservator of Forest Sirsi subdivision office-581401 and submitted while submitting the tender in the bid

27. The tenderers should submit the sample to the said office before the expiry of the tender period

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer

is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
