If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience to their meeting of quality and technical specifications. 4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation, shall upload supporting documents to prove his eligibility for Relaxation.
5. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relaxation acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during bunch bids, the category of primary product having highest value should meet this criterion.
6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated on portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documents shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference on the basis of documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity. Contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be available as per line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Org; contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should be considered.
8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA
  - i. If number of technically qualified bidders are only 2 or 3.
  - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
  - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
  - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1.
  - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1.

#### **1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 2% time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 2% during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from delivery order and in cases where option clause is exercised during the extended delivery period the addition shall be till the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original period}$  (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time shall be the original period. The Purchaser may extend this calculated delivery duration up to the original delivery period while bidder must comply with these terms.
