1. In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. The bidder should be a manufacturer in India of fabric belts (EP belts).

2. The bidder should have manufactured in India and supplied fabric belts (EP belts) of 1400 mm or higher width for a minimum quantity of 600 meters in a maximum of two orders to Govt./Quasi Govt./Public Sector Undertakings/Public Limited Companies/Independent Power Plant in India within the last seven years prior to the original scheduled date of tender opening and the supplied belt should have worked satisfactorily for a minimum period of one year or 5,000 hours for carrying over burden / Mineral / Coal / Lignite, as on the original scheduled date of opening of the first cover.

3. The bidder should have the vulcanizing press of their own for manufacturing fabric belt (EP belts) within India of 1600mm width as on the original scheduled date of opening of the first cover.

NOTE: If the bidder is a previous supplier of EP belts of 1400mm or higher width to NLCIL/NTPL satisfying the above PQR-1,2 & 3 conditions, it is sufficient for the bidder to mention NLCIL/NTPL purchase order/IRR reference towards documental evidences. The bidder will be qualified based on their past performance with NLCIL/NTPL.

Financial Requirements:

4. a) Average annual turnover of the bidder for the three financial years immediately preceding the original scheduled tender opening date should not be less than 30% of the annualized tender value.

In case, if a bidder meets the technical QR but could not furnish his / their standalone audited financial statement of three consecutive financial years preceding the last financial year for evaluating the average annual turnover, due to the incorporation / formation of the company / firm of the bidder, within a period of less than 3 years from the original scheduled date of tender opening, then, such bidder shall also be considered and the average annual turnover of such bidder shall be arrived at as below:

- In cases, where standalone audited financial statement (Profit & Loss Account and Balance Sheet) for the last financial year immediately preceding the original scheduled date of Tender opening are not available, a certificate would be required from the bidder stating that the financial statement of the bidder are under audit as on the date of tender opening. In such case, the standalone audited financial statement of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).

- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**

**This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.**

**However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.**
