1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM\\_No.1\\_4\\_2021\\_PPD\\_dated\\_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE 50% : The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 50 percent with the consent of the service provider

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Technical Bid: shall consist of i. EMD & ii. Documents in support of fulfillment of the laid down ELIGIBILITY CRITERIA as under:

**(a) Financial Eligibility Criteria:** The bidder will be qualified only if they have minimum financial capabilities as below:

**(i) T1 Annual Turnover:** - The bidder should have an aggregate financial turnover not less than 1.5 times the advertised bid value during last three previous financial years and in the current financial year up to the date of opening of the tender. The audited balance sheet reflecting financial turnover certified by chartered accountant with his stamp, signature and membership number shall be considered.

**(ii) T2 liquidity:** - The bidder should have access to or has available liquid assets, lines of credit and other financial means to meet cash flow that is valued at 5 % of the estimated bid value net of applicant's commitments for other contracts. The audited balance sheet and/or banking reference certified by chartered accountant with his stamp, signature and membership number shall be submitted by the bidder along with bid. etc.

1. Banking reference should contain in clear terms the amount that bank will be in a position to lend for this work to the applicant/member of the joint venture /consortium. In case the Net current Assets (as seen from the balance sheets) are negative, only the banking reference will be considered. Otherwise, the aggregate of the Net current Assets and submitted Banking reference shall be considered for working out the Liquidity.

2. The banking reference should be from a scheduled Bank in India and it should not be more than 3 months old as on date of submission of bids.

3. Bidders should also upload the details as per prescribed format mentioned at Appendix II and ANNEXURE-J.

**Note:** - Tenders having opening date between April to September, some firms are not ready with audited balance sheet of previous year certified by chartered accountant, in such cases a certificate from chartered accountant issued on the basis of any other government approved document like GST Returns/VAT statement (if applicable) may be considered. Certificate from chartered accountant issued on the basis of any other government approved document like GST Returns/VAT statement (if applicable) for current financial may be considered. **(Authority: RB Letter No. 2016/EnHM/06/02, Dated 18.10.2018).**

**(b) Technical Eligibility Criteria:** The tenderer should have satisfactorily in the last three previous financial years and the current financial year upto the date of opening of the tender completed\* one similar single service contract\*\* for a minimum of 35% of the advertised value of the bid.

\*Completed service contract includes on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of the bid.

\*\*Similar work implies **“Pest and Rodent control work executed in Railway coaches/station premises Or Government/ Public sector unit (PSU) warehouses /godowns”**.

**(Authority: Hq Letter no. EnHM/115/3/Pest and Rodent Dated 11.05.2018)**

c) Total penalty imposed for unsatisfactory performance in the similar qualifying contract should not exceed more than 7% penalty of the contract value. Confirmation and documentary evidence must be submitted by the tenderer duly verified by the Agency that had awarded the contract.

d) The pest control operations shall be done only by agencies, which have been approved by the Plant Protection Officers of the concerned state's agriculture department or Central Insecticides Board and Registration Committee (CIB&RC) Faridabad. They should have a valid license with clear endorsement for permission to carry out commercial domestic pest control. The license should not be only for selling, exhibiting and stocking insecticides.

e) **System of Verification of Tenderers Credentials:** The tenderer shall submit affidavits/undertakings stating that they are not liable to be disqualified and all their statements/documents submitted along with bid are true and factual. **Standard format of the affidavit/undertaking**

**ng to be submitted by the bidder is enclosed as ANNEXURE - G-1, ANNEXURE - G-2 & Appendix-V. Non-submission of these affidavits/undertakings by the bidder shall result in summary rejection of his/their bid.** And it shall be mandatorily incumbent upon the tenderer to identify state and submit the supporting documents duly self-attested by which they/he is qualifying the Qualifying criteria mentioned in tender document. It will not be obligatory on the part of Tender Committee to scrutinize beyond the submitted document of tenderer as far as his qualification for the tenderer is concerned.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller.
