The following **Additional Terms and Conditions (ATC)** shall be complied with by the Service Provider, **in conjunction with the GeM General Terms and Conditions (GTC), Service Level Agreement (SLA)** and other conditions specified in the bid document for the subject work:

- (1)** The Service Provider shall carry out repair / maintenance / overhauling services **at the site, office, Service Provider's workshop, or OEM-authorized workshop**, as required and as directed by the **Engineer-in-Charge (GE / E-in-C)**.
- (2)** The Service Provider may be required to submit a **detailed financial breakup** of the services rendered, indicating **cost of replaced unserviceable (U/S) parts, consumables, labour / installation charges, and any other associated costs**, duly signed and stamped on the firm's letterhead or submitted as **digitally signed and verifiable statement**, as applicable. The financial breakup shall be utilized **only for verification, reasonableness assessment and payment purposes** and shall **not affect bid ranking or contract rates**.
- (3)** The Service Provider may be required to produce **relevant purchase vouchers, invoices, challans or equivalent documentary evidence** for replacement of parts or supply of any items included in the service, for verification and payment purposes.
- (4)** The Service Provider may be required to attend **urgent or emergency breakdowns**, as well as to carry out **preventive and periodic repair / maintenance / overhauling**, strictly as per the scope of work and directions of the Engineer-in-Charge.
- (5)** The Service Provider shall provide **warranty on replaced parts** as per **OEM warranty policy or for a minimum period of six (06) months from the date of supply / service, whichever is longer**. An **undertaking / warranty certificate** to this effect shall be furnished by the Service Provider.
- (6)** The Service Provider shall furnish details of **local office address at Gorakhpur**, complete correspondence address, and **single point of contact**, along with **documentary proof**, for effective coordination during the contract period.

(7) The **credit value of unserviceable (U/S) parts / scrap**, as applicable and as per the **Schedule of Credit**, shall be **deducted from the payable amount** in accordance with **IAFW-2249 and MES procedures**.
