3. **Certificates**

1. Tenderers are advised to read all the clauses carefully including its notes/special notes as mentioned in BID.
2. Document uploaded in the Buyer added ATC along with this bid shall be applicable, bidder need to go through the document attached and to upload compliance/documents as per the bid requirement.
3. Extra KMs Charges & Extra Hours Charges will be govern as per the Scope of Work.
4. The bidder shall have experience of providing at least 11 vehicles at a time for at least 01 day(s) to Central government/State government /PSU/Public listed company in Delhi/NCR in single agreement/contract in last 03 years. Firm to submit documentary evidence of experience and satisfactory performance while tendering, failing which offer will be rejected.

Bidder shall submit documentary evidence of compliance of ownership of minimum fleet size. Vehicles should only be registered on firm/owner's name in RTO office. Noncompliance and non-ownership of above stipulated minimum fleet size shall lead to summarily rejection of bid.
6. Registered office of Bidder must be in Delhi/NCR. Documentary evidence of same to be submitted along with the bid, otherwise the bid shall be treated as un-responsive and it will be summarily rejected.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
