5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

2. **Special Conditions /instructions:** The uniforms will be stitched as on required basis and maximum quantity mentioned in contract. A Tailor representative is to be deputed on monthly basis for taking measurement of personnel due for uniforms at ICGS Delhi and Noida. Cloth for stitching of uniforms to be collected from Clothing Issue Centre, Noida and the stitched uniforms are to be delivered to Clothing Issue Centre, OTM Complex, Sector-62, Noida by the firm at his own expenses.

5. Tailor is responsible for stitching of arm badges (Provided by the individual at the time of measurement only), making the holes for shoulder stripes in case of Subordinate Officers, and provision to stitching of loops for name talley, ribbons & decorations for all uniforms.

6. Stitching charges are to be inclusive for brass buttons (electroplated) required to be stitched in Jacket DB black wool for No.1 and YST Arms Badge to be stitched in Jacket provided by this station.

7. Uniforms not stitched as per measurement of the individual /soiled and stained uniforms will be rejected and new uniform will be provided by the firm at his own expense.
