OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. - Supplied materials shall be unloaded at NUPPL stores after getting necessary clearance from the material gate.
- Warranty/Guarantee: 12 Months from the date of supply.
- The supplier shall have to strictly abide by the guidelines of Central Government/State Government and ensure compliance.
- All the safety measures during loading and transportation will have taken into consideration by the contractor.
- NUPPL decision on interpretation of any terms and conditions set forth in the purchase order shall be final and binding on the supplier or the service provider.
