1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. OEM

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should

be submitted.

7. **Turnover**

2. Bid price to include all cost components such as all applicable taxes, transportation, packing and supply of item up-to delivery location.
3. Bidder's Shop/ Office/ Service Centre must be available in the Andaman & Nicobar Island's Jurisdiction. Shop Registration Document/Certificate such as Shop & Establishment Registration Certification or GST Registration Certificate of consignee state must be submitted.

4. The items to be supplied should be of branded/reputed manufacturer and it should be new & original being manufactured by original equipment manufacturer (OEM).

5. In case of MSME, bidder must provide valid MSME registration certificate where the activities should match with the scope of this bid.

6. The bidder shall submit an undertaking stating that neither the bidder nor the OEM has been blacklisted, debarred, or declared ineligible to participate in any procurement process by any Government authority, public sector undertaking, or regulatory body as of the date of bid submission

8. Samples of all the above items as per the bid specification has to be submitted at the Buyer location on or before Bid Opening Date & Time for checking & verification of the sample of items by technical committee by this Directorate. Unbranded or Counterfeit Items will not be considered for Technical Evaluation.

9. The successful bidder may supply the remaining quantity after award of bid and the samples of disqualified bidders will be returned after obtaining approval from competent authority.

10. The bidder must accept all ATC clauses. Document has to be uploaded along with bid documents.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
