In case the date of constitution/incorporation of the bidder is less than 3 years old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. The documentary evidence of turnover in the form of certified audited balance sheet of relevant period and turnover certificate must be certified by Chartered Accountant (CA). Bidders must provide a CA certificate of their turnover. Last 3 years average turnover should not be less than requirement. This turnover must be OEM & CA certified. (Annual turnover value will be applicable as per Gujarat State Procurement Policy 2024, Industries & Mines Department, Resolution No: SPO 102021-188 460-CH dated 14-03-2024.) **The average turnover of the bidder/seller should be at least 2 times or more of the bid's estimated value/estimated value of quoted item(s)/product(s).**

The bidder has to accept both the specifications (as per GeM category specification) and additional specification parameters added by the buyer and submit the documents with firm's signature and stamp for submission of technical offer in the bid.
