1. The construction, tolerances, marking and information of the drinking water cooler shall conform to the IS 1475.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. Financial Standing & Turnover:

The minimum average annual financial turnover of the bidder during the last three financial years (FY 2022-23, FY 2023-24, and FY 2024-25) must be at least 50% of the estimated bid value. Bidders must upload a Copy of the Audited Balance Sheet and Profit & Loss Statement duly certified, stamped, and signed by a registered Chartered Accountant with a valid Unique Document Identification Number (UDIN).

Local Service Support (Uttar Pradesh):

To ensure prompt maintenance and minimize downtime of public drinking water infrastructure, the supplier must have a functional, dedicated Service Centre/Escalation Desk in the State of Uttar Pradesh (preferably within or adjoining the district of the Buyer Nagar Palika). The bidder must submit proof of the service center (e.g., GSTIN registration, electricity bill, or property lease deed) along with the contact names, active phone numbers, and emails of the service engineers. The bidder must guarantee a maximum turnaround time of 24 to 48 hours for resolving complaints.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
