If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

6. Vehicle should not be older than 3 years during entire contract period , and shall be maintained in roadworthy condition at all times (Vehicle should not be older purchase than of Jan 2025.).
7. In case of breakdown, equivalent or higher category vehicle shall be provided within:
 - o 1 hour at HQ
 - o 2 hours at outstation locations
8. No extra payment shall be made for:
 - o Night duty
 - o Early reporting / late release
 - o Outstation halt
 - o Adverse weather or terrain
9. The rate is inclusive of fuel, driver wages, bata, maintenance, tolls, permits, taxes, and all incidental charges, and no additional claim shall be entertained.
10. The vehicle shall report daily with sufficient fuel (preferably full tank) and shall not be withdrawn citing fuel or operational issues.
11. The driver shall have minimum 5 years experience, valid license, and knowledge of local railway routes and sectional roads.
12. The driver shall maintain discipline, proper uniform, and courteous behavior , and shall not use mobile phone while driving or report under intoxication
13. A logbook/trip sheet shall be maintained with complete details and verified by Railway officer; payment shall be based on authenticated records.
14. All statutory documents (RC, Insurance, Permit, PUC, etc.) shall be valid and kept in vehicle, with copies submitted to office.
15. The contractor shall ensure compliance with labor laws and statutory provisions, and Railway shall have no liability.
16. Payment shall be made on pro-rata basis depending on actual days of deployment, and non-deployment shall attract deductions.
17. Non-availability, delay (>30 minutes), breakdown, poor vehicle condition, or driver misconduct shall attract penalties in addition to or as per GeM SLA.
18. The vehicle shall be available for inter-division/inter-state movement and emergency deployment without any additional charges.
19. The Railway reserves the right to reject or replace vehicle/driver at any time if found unsuitable, without assigning reasons.
20. Any fraudulent billing, misrepresentation, repeated failures, or safety

violations shall lead to recovery, termination of contract, and further administrative action.

21. In case of any defaults, supplier shall attract penalties in addition to or as per GeM SLA.

22. Supplier must provide vehicle documents/driver documents as per office requirement at the time of awarding of contract.

23. The contractor shall arrange to submit copies of Photo Identity Card, Driving License and other relevant details of the driver along with registration details and tax payment records of the vehicle to the office of SR.DEN/CO ORD/TVC before commencement of work.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
