Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

- iv) If any document is found to be fake, forged, tampered, or non-genuine at any stage, including after placement of purchase/work order, punitive action shall be taken as per SAIL guidelines.

IMPORTANT NOTE

1. RPN Clause: Subject to the terms and conditions of the GeM contract, if the supplier neglects or fails to perform the contract within the agreed time for reasons other than force majeure, the purchaser, after giving 14 to 30 days' notice or any mutually extended period, may take risk purchase action for or similar materials at the risk and cost of the supplier for the undelivered quantity. This right is in addition to the right to terminate the contract. Any price differential incurred shall be borne by the defaulting supplier, and RSP reserves the right to recover the same from pending bills in other SAIL units. The defaulting supplier shall have no claim over the quantity not supplied.

2. RSP shall place back-up orders against GeM contracts on successful bidder (s). The back-up order number shall be mentioned in the invoices for proper accounting.
3. Bids are liable to be rejected if any of the required certificates/documents as per bid document, ATC, or corrigendum are not uploaded.
4. The delivery period quoted shall be strictly as per the GeM bidding document.
5. Latest Udyam Registration Certificate shall be attached for MSE preference.
6. For Make in India, firms shall attach a declaration indicating their status as Class-I or Class-II supplier.
7. Percentage of local content and place of value addition shall be mentioned in the Make in India declaration, which must be issued by the OEM.
8. Only relevant documents shall be uploaded for technical and commercial scrutiny. Additional documents beyond requirement shall not be considered.
9. Prices quoted shall be on Rourkela Steel Plant Stores/User Site basis.
10. In case any adverse report is received against a tenderer regarding capability or performance, the tender is liable to be rejected even after opening of the price bid, with recorded reasons.

Eligibility Criteria

1. THE TENDERER MUST BE A MANUFACTURER OF VALVE. NECESSARY SUPPORTING DOCUMENTS TO BE SUBMITTED. IN CASE OF TRADER/ DEALER, THEY SHOULD SUBMIT BID SPECIFIC AUTHORIZATION LETTER FROM THE OEM IN THEIR ORIGINAL LETTER HEAD.
2. THE BIDDER SHOULD HAVE MANUFACTURED AND SUPPLIED GATE VALVES OF SIZE NB 80 OR ABOVE AT LEAST ONCE TO CENTRAL OR STATE GOVERNMENT ORGANIZATION OR PSU/ PUBLIC LIMITED COMPANIES IN INDIA DURING LAST 7 YEARS FROM THE DATE OF ISSUE OF NIT.

IN ORDER TO SUBSTANTIATE THEIR TECHNICAL CAPABILITY, THE BIDDER SHALL ENCLOSE DOCUMENTARY EVIDENCE SUCH AS COPY OF LETTER OF AWARD/CONTRACT AND COMPLETION CERTIFICATE/INSPECTION CERTIFICATE/DISPATCH CLEARANCE/ MATERIAL RECEIPT NOTE.

the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
